ORDER:-

In the order first read above, a State Level Co-ordination Committee has been formed under section 13 of National Trust for the Welfare of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities Act, 1999 under the Chairmanship of Principal Secretary, Welfare of Differently Abled Persons Department. The above Committee should convene regular meetings atleast once in six months and co-ordinate various Schemes, Programmes and Activities of the National Trust.

2. In the letter second read above, the State Co-ordinator, State Nodal Agency Centre, National Trust has requested to reconstitute the State Level Co-ordination committee. Based on the request of the State Co-ordinator, State Nodal Agency Centre (Tamil Nadu), the Commissioner for Welfare of the Differently Abled was requested to send a suitable proposal for reconstitution of the committee.

3. In the letter third read above, the Director for Welfare of the Differently Abled has stated that in order to implement the scheme under National Trust Act, 1999 and to monitor the performance of Local Level Committee (LLC) to appoint Legal Guardianship (LGS) and also to expedite action for issuing Legal Guardianship Certificate, it is necessary to increase the members of the State Level Co-ordination Committee. Hence, the Director for Welfare of the Differently Abled has requested to issue orders for reconstituting a State Level Co-ordination Committee to implement National Trust Schemes and to issue Legal Guardianship certificates under National Trust Act, 1999 with the following members:-
