ORDER:

As per section 33(i) of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) "the appropriate Government shall identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the provisions of section 34" of the said Act.

2. In the Government order sixth read above, certain posts are identified suitable for differently abled persons for appointment including Civil Judge / District Judge (entry level) in Tamil Nadu State Judicial Service.

3. In the letter ninth read above, the Registrar (Recruitment), High Court of Madras has requested certain amendments to Government order six read above. The proposals of the Registrar (Recruitment), High Court of Madras was examined in consultation with the State Commissioner for the Differently Abled.
