ORDER:

During the Water Resources Department's Demand for Grants for the year 2021-2022 held on 23.08.2021, the Hon'ble Minister of Water Resources announced on the floor of the Assembly that "190 Check dams, 4 Subsurface dykes, 6 Barrages, 2 Tail end regulators and 12 Anicuts in all Districts will be constructed during the current Financial year".

2. Based on the above announcement, in the letter first read above, the Chief Engineer, Plan Formulation, Water Resources Department has sent a proposal for construction of 14 Nos. of Check dams in Dindigul, Erode and Coimbatore Districts in Coimbatore Region at an estimated cost of Rs.39.5825 crore and the proposals envisage the following:

1. Construction of a Check Dam across the Kumittipathi river in S.F.No. 402 of Thirumalaiyampalayam Village in Coimbatore South Taluk of Coimbatore District at an estimated cost of Rs.2.34 Crore.

The proposed Check Dam site lies across the Kumittipathi River in S.F.No. 402 of Thirumalaiyampalayam Village in Coimbatore South Taluk of Coimbatore District, in Walayar Sub-basin of Bharathapuzha basin.

2. Construction of a Check Dam across the Santhanavarthini River near Kulathur Village of Vedasanthur Taluk in Dindigul District for estimated cost of Rs.3.70 Crore.

The proposed Check Dam site lies near Kulathur Village of Vedasanthur Taluk in Dindigul District in Amaravathi Sub-basin of Cauvery basin.

3. Construction of a Check Dam across the Odai near Naripon pallam at Chinnalagu Naickanur H/O R.Kombai Village in Vedasandur Taluk of Dindigul District at an estimated cost of Rs.1.05 Crore.

The proposed Check Dam site lies near Naripon pallam at Chinnalagu Naickanur H/O R.Kombai Village in Vedasandur Taluk of Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

4. Construction of a Check dam across the Periya odai in Javvathupatti Village of Oddanchatram Taluk in Dindigul District at an estimated cost of Rs.2.00 Crore.

The proposed Check Dam site lies in Javvathupatti village of Oddanchatram Taluk in Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

No patta land acquisition is involved in this scheme. But an extent of 0.92 acres of odai poramboke land in Javvathupatti Village is required.

5. Construction of a Check Dam across the Santhanavarthini River near Seelapadi Village in Dindigul East Taluk of Dindigul District at an estimated cost of Rs.3.50 Crore.

The proposed Check Dam site lies near Seelapadi Village in Dindigul East Taluk of Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

6. Construction of a Check Dam across the Santhanavarthini River in Mullipadi Village in Dindigul East Taluk of Dindigul District at an estimated cost of Rs.4.80 Crore.

The proposed Check Dam site lies in Mullipadi Village in Dindigul East Taluk of Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

7. Construction of a Check Dam across the Santhanavarthini River near Periyakottai Village of Dindigul East Taluk in Dindigul District at an estimated cost of Rs.4.80 Crore.

The proposed Check Dam site lies near Periyakottai Village of Dindigul East Taluk in Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

8. Construction of a Check Dam across the Mangarai River in S.F.No.470 at Vellaiyampatti Hamlet of Silvarpatti Village of Dindigul West Taluk in Dindigul District at an estimated cost of Rs.2.55 Crore.

The proposed Check Dam site lies near Vellaiyampatti Hamlet of Silvarpatti Village of Dindigul West Taluk in Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

9. Construction of a Check Dam across the Mangarai River at Silvarpatti village in Dindigul West Taluk of Dindigul District at an estimated cost of Rs.1.97 Crore.

The proposed Check Dam site lies near Silvarpatti Village in Dindigul west Taluk of Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

10. Construction of a Check Dam across the Mangarai river near Rajapudur at Kodalvavi Village of Dindigul Taluk in Dindigul District at an estimated cost of Rs.1.275 Crore.

The proposed Check Dam site lies near Rajapudur at Kodalvavi Village of Dindigul Taluk in Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

11. Construction of a check Dam across the Kodaganar river at Ponnimanthurai Hamlet of Sindalagundu Village of Dindigul Taluk in Dindigul District at an estimated cost of Rs.3.12 Crore.

The proposed Check Dam site lies near Ponnimanthurai Hamlet of Sindalagundu Village of Dindigul Taluk in Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

12. Construction of a Check Dam across the Santhanavarthini river near Rajakkapatti Village of Dindigul East Taluk in Dindigul District at an estimated cost of Rs.4.80 Crore.

The proposed Check Dam site lies near Rajakkapatti Village of Dindigul East Taluk in Dindigul District, in Amaravathi Sub-basin of Cauvery basin.

13. Construction of a Check Dam across the Kuranganpallam Odai in S.F.No. 118 of Kolathupalayam Village near Arampalayam in Kodumudi Taluk of Erode District at an estimated cost of Rs.1.8975 Crore.

The proposed Check Dam site lies in S.F.No. 118 of Kolathupalayam Village near Arampalayam in Kodumudi Taluk of Erode District, in Cauvery Sub-basin of Cauvery basin.

14. Construction of a Check Dam across the Kuranganpallam Odai in S.F.No. 192 of Kombanaipudur Village in Kodumudi Taluk of Erode District at an estimated cost of Rs.1.78 Crore.

The proposed Check Dam site lies across Kuranganpallam odai in S.F.No. 192 of Kombanaipudur Village in Kodumudi Taluk of Erode District, in Cauvery Sub-basin of Cauvery basin.

3. The Chief Engineer, Plan Formulation, Water Resources Department has stated that no land acquisition is involved in these Schemes and the Estimates have been prepared based on the Schedule of Rates for 2021- 2022 and requested for administrative sanction for Construction of 14 Nos. of Check dams in Coimbatore Region at an estimated cost of Rs.39.5825 crore.

4. In the letter second read above, the proposal of the Chief Engineer, Plan Formulation, Water Resources Department for construction of the above mentioned 14 Check Dams have been forwarded to NABARD for loan assistance under RIDF XXVII for the year 2021-2022 at a cost to Rs.38.72 Crore.

5. The Government, after careful examination, have decided to accord sanction for 14 Check Dams at an estimated cost of Rs.38.72 Crore, which have already been proposed to NABARD for loan assistance under RIDF. Accordingly, sanction is accorded for construction of 14 Nos. of Check dams in Dindigul, Erode and Coimbatore Districts in Coimbatore Region at an estimated cost of Rs.38.72 crore (Rupees Thirty eight crore and seventy two lakh only) in anticipation of NABARD loan assistance under RIDF XXVII for 2021-2022, as detailed below:

The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to send necessary proposals to Government in Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate 2021-2022 to Finance (PW-II / BG-I) Department at an appropriate time without fail.
