#### ORDER:

In the Government Order first read above, Administrative Sanction has been accorded to take up 100 water bodies at an outlay of Rs.10092.67 lakhs under Phase IX of Repair, Renovation and Restoration (RRR) scheme under PMKSY (HKKP).

- In the letter 2<sup>nd</sup> read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has stated that in the clause 8(e) of Guidelines of RRR scheme, it has been stipulated that "Concurrent Evaluation is to be got done by the State Government by involving independent agencies."
- 3. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has also stated that an estimate has been prepared for an amount of Rs.99.80 lakhs to engage an agency / institution for carrying out the Concurrent evaluation for the 100 water bodies under Phase IX of RRR Scheme under State fund. The Abstract of the estimate are as follows:-

- 4. He has also stated that the Concurrent Evaluation study is a special nature of work and it is not covered under the Schedule of Rates. Hence, the estimate has been prepared based on quotations.
- 5. He has also stated that the scope of the Concurrent Evaluation study of tank works includes study / evaluation of (i) Repair/ Reconstruction of conveyance system (ii) Repair/ Reconstruction of weirs, (iii) Repair/ Reconstruction of sluices (iv) Construction of recharge structures (v) Catchment treatment (de-silting of Channels) (vi) De-Silting in terms of quantum of silt removed (vii) Strengthening of bund (viii) Quality Control measures and sustainability.
- 6. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has therefore requested the Government to accord Administrative Sanction for a sum of Rs.99.80 lakhs to engage a consultant to carry out concurrent evaluation for RRR works in 100 water bodies under Phase IX of PMKSY.
- 7. The Government have examined the proposal of the Engineer- in-Chief and Chief Engineer (General), Water Resources Department, Chennai and hereby accord Administrative Sanction for a sum of Rs.51.00 lakhs (Rupees Fifty one Lakhs only) to engage a consultant to carry out concurrent evaluation for Repair, Renovation and Restoration works in 100 water bodies under Phase IX of Har Khet Ko Pani component of Pradhan Mantri Krishi Sinchayee Yojana. The Government have also directed the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai to follow the extant procurement procedure in the Tamil Nadu Transparency in Tenders Act to ensure correct price discovery.
- 8. The expenditure sanctioned at para 7 above shall be debited to the following head of account:-

"4711 – Capital Outlay on Flood Control Projects – 01 Flood Control – 103 Civil Works – State's Expenditure - LG Additional State Share for Repair, Renovation and Rehabilitation of Water Bodies (Top up) – 416 Major Works - 01 Major Works."

- 9. Necessary additional funds of Rs.51,00,000/- will be provided in Revised Estimate / Final Modified Appropriation 2023 –2024. However, this expenditure shall be brought to the notice of Legislature by way of **Specific Inclusion** in the Supplementary Estimate 2023 –2024. Pending provision of such funds, the Engineer in Chief, Water Resources Department is authorized to incur the expenditure sanctioned in para 7 above. The Engineer-in-Chief, Water Resources Department, Chennai is also directed to include the above item of expenditure while sending the budget proposal for Revised Estimate / Final Modified Appropriation 2023– 2024 and also send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimate 2023–2024 to Finance (PW-II/BG-I) Department at an appropriate time without fail.
- 10. Further, the sanctioned amount shall be deposited in the Single Nodal Bank Account of the Tamil Nadu Water Resources Department as per the details given below:-
