ORDER:

In the letter read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has stated as following:-

- i) The Government of India have included 9 water bodies under Phase V of RRR Scheme and released the Central Assistance of Rs.125.21 lakhs as first instalment.
- ii) Subsequently, the Government have accorded Administration Sanction for Rs.417.37 lakhs for the 9 tanks in the phase V pertaining to Dindigul district in G.O.(D) No.237, Water Resources (WR2) Department, dated 16.12.2021.
- iii) As per clause 3.3 (g) of the Guidelines and Memorandum of Understanding (MoU) of RRR Scheme "State Government is to take necessary steps for declaring the water body boundry through Government order and to ensure removal of encroachments in the water body spread area / water body boundary before submitting the proposal for inclusion of work on the water body under RRR of Water Bodies. All water bodies to be included under the scheme are to be certified by the State Government to be encroachment free."

- IV) Also as per Memorandum of Understanding (MoU) (Release of Central Assistance (viii)), "State Government is to take necessary steps for declaring the water body boundary through a Government Order and ensure removal of encroachments in the water body spread area/ water body boundary before submitting the proposal for release of 2nd instalment of grant for completion of work on the water body under Repair, Renovation and Restoration (RRR)."
- V) Notice showing the index map of Tank and Boundaries in the form II prescribed in the subrule (3) of Rule 5 of Tamil Nadu Protection of Tanks and Eviction of Encroachment Act 2007, have been published as encroachment free for the 9 tanks of Repair, Renovation and Restoration (RRR) phase-V.
- 2. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has requested the Government to accord approval for declaring that 9 water bodies in Phase V of PMKSY (Har Khet Ko Pani) are free from any kind of encroachment.
- 3. Based on the details furnished by the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai, the Government have decided to accord approval for declaring that 9 water bodies in Phase V of PMKSY (Har Khet Ko Pani) are free from any kind of encroachment.
