Order:

In the letter read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has submitted the 3 estimates for disposal of old unserviceable materials kept in the Periyar Dam Special Division, Cumbum, Gundar Basin Division, Madurai and Ground Water Division, Karaikudi.

Periyar Dam Special Division, Cumbum

- The Single Technical Committee has inspected the materials kept at Shanmuganadhi Reservoir Sub Division 1 & 2, Rayappanpatti and Periyar Dam Special Sub Division, Cumbum on 20.04,2023.
- The old unserviceable & obsolete materials are very old and rusted. The parts were also in worn out condition and obsolete.
- Considering the present conditions of the items available at site, the Single Technical Committee has finalized the rates for the items mentioned in the Survey Report.
- The items are beyond repair due to non-availability of spare parts.
- To avoid further loss to Government by way of rusting and loss in reduction of weight, market cost reduction and to avoid the expenditure on storage, the surveyed materials have to be disposed off. Hence, the Single Technical Committee has recommended the

scrap proposal for a total value of Rs.1,43,095/- (Rupees one lakh forty three thousand and ninety five only).

<u>Gundar Basin Sub Division, Kariapatti & Gundar Basin Sub Division, Usilampatti</u>

- The Single Technical Committee has inspected the materials kept at Gundar Basin Sub Division, Kariapatti & Gundar Basin Sub Division, Usilampatti on 20.04.2023 & 21.04.2023.
- The old unserviceable & obsolete materials are very old and rusted. The parts were also in worn out condition and obsolete.
- Considering the present conditions of the items available at site, the Single Technical Committee has finalized the rates for the items mentioned in the Survey Report.
- The items are beyond repair due to non-availability of spare parts.
- To avoid further loss to Government by way of rusting and loss in reduction of weight, market cost reduction and to avoid the expenditure on storage, the surveyed materials have to be disposed off. Hence, the Single Technical Committee has recommended the scrap proposal for a total value of Rs.2,47,422/- (Rupees two lakh forty seven thousand four hundred and twenty two only).

Ground Water Division, Karaikudi

- The Single Technical Committee has inspected the materials kept at Ground Water Sub Division, Karaikudi on 21.04.2023.
- The old unserviceable & obsolete materials are very old and rusted.
 The parts were also in worn out condition and obsolete.
- Considering the present conditions of the items available at the site, the Single Technical Committee has finalized the rates for the items mentioned in the Survey Report.
- The items are beyond repair due to non-availability of spare parts.

To avoid further loss to Government, by way of rusting and loss in reduction of weight, market cost reduction and to avoid the expenditure on storage, the surveyed materials have to be disposed off. Hence, the Single Technical Committee has recommended the scrap proposal for a total value of Rs.2,92,000/- (Rupees two lakh and ninety two thousand only).

- 2. The Single Technical Committee and the Chief Engineer, Water Resources Department, Operation and Maintenance, Chennai have recommended the above proposals.
- 3. Based on the recommendation, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has requested the Government to accord sanction for disposal of old unserviceable materials kept in the Periyar Dam Special Division, Cumbum, Gundar Basin Division, Madurai and Ground Water Division, Karaikudi at an

estimated amount of Rs.6,82,517/- (Rupees six lakh eighty two thousand five hundred and seventeen only) (Periyar Dam Special Division - Rs.1,43,095/-, Gundar Basin Division - Rs.2,47,422/- & Ground Water Division-Rs.2,92,000/-).

- 4. The Government after careful consideration have decided to accept the request of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai. Accordingly, sanction is accorded for disposal of old unserviceable materials kept in the Periyar Dam Special Division, Cumbum, Gundar Basin Division, Madurai and Ground Water Division, Karaikudi at an estimated amount of Rs.6,82,517/- (Rupees six lakh eighty two thousand five hundred and seventeen only).
- 5. The amount received from the sale / disposal of unserviceable machineries and old materials shall be credited to the following existing Head of Account:-
