ORDER:

In the G.O. 1st read above, the Government have accorded administrative sanction for Construction of Check dam and Recharge shafts across Vaigai River for recharge of ground water near Aarapalayam of Madurai West Taluk in Madurai District for a value of Rs.11,98,50,000/-supported by NABARD loan assistance under RIDF XXVI for the year 2020 – 2021.

- 2. In the letter 2nd read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has stated as follows:
 - (i) Technical Sanction for the above work was done by the Chief Engineer, Water Resources Department, Madurai Region for the same amount of Rs.11,98,50,000/-.
 - (ii) The Tender process was carried out under the helm of Superintending Engineer, Water Resources Department, Periyar Vaigai Basin Circle, Madurai. The work was entrusted to M/s.KAIG Construction Private Limited, Madurai vide

Periyar Vaigai Basin Circle Agreement No.05SE/PVBC/2021-2022 with acceptance of value Rs.12,31,74,583/- which is Rs.33,24,583/- excess over the Administrative sanction amount and Rs.57,55,054/- excess over the value put to tender.

- (iii) After detailed discussions, the Tender Award Committee recommended the proposal to Government for their approval of Net Excess of Rs.54,77,399/- over the Administrative sanction after receiving ample recommendation from Technical Advisory Committee held on 07.09.2022.
- 3. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department has requested that the Revised Administrative Sanction for Construction of Check dam and Recharge shafts across the Vaigai River for recharge of ground water near Aarapalayam of Madurai West Taluk in Madurai District may be obtained for an amount of Rs.12,53,27,399/-.
- 4. Based on the recommendations of the Technical Advisory Committee and Tender Award Committee, the Government after careful examination, have decided to accept the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and accordingly, Revised Administrative Sanction is accorded for Construction of Check dam and Recharge shafts across Vaigai River for recharge of ground water near Aarapalayam of Madurai West Taluk in Madurai Districtat an estimated cost of Rs.12,53,27,399/- (Rupees Twelve crore fifty three lakh twenty seven thousand three hundred and ninety nine only) which is Rs.54,77,399/- excess over the Administrative Sanction amount of Rs.11,98,50,000/- for which sanction was accorded in G.O.(4D) No.36, Public Works (P1) Department, dated 22.02.2021.
- 5. The excess expenditure sanctioned in para 4 above shall be debited to the following head of account: (40-01)

"4700 Capital Outlay on Major Irrigation — 05 Vaigai Basin — 800 Other Expenditure — State's Expenditure — DB Weir- NABARD assistance - 416 Major works — 01 Major Works.

6. Necessary additional funds of Rs.54,77,399/- will be provided in Revised Estimate / Final Modified Appropriation 2023 – 2024. However, this expenditure shall be brought to the notice of legislature by way of Specific Inclusion in the Supplementary Estimates 2023 – 2024. Pending provision of such funds the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is authorized to incur the expenditure sanctioned in para.4 above. The Engineer-in-Chief and

Chief Engineer (General), Water Resources Department, Chennai is directed to include the above item of expenditure while sending the budget proposal for Revised Estimate / Final Modified Appropriation 2023 – 2024 and also send necessary draft Explanatory Notes for Inclusion of the expenditure in the Supplementary Estimate 2023 – 2024 to Finance (PW-II / BG-I) Department at an appropriate time without fail.
