Tamil Nadu Water Resources Department – Administrative Sanction to take up Repair, Renovation and Restoration of 100 water bodies at an outlay of Rs.10092.67 Lakhs under Phase IX of Har Khet Ko Pani component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) with Central State Share ratio 60 (Central- Rs.6055.60 lakhs): 40 (State-Rs.4037.07 lakhs) -Accorded – Orders- Issued.

ORDER:

Hon'ble Minister (Water Resources) has announced on the floor of Legislative Assembly on 06.04.2022 during the debate on the demand of Water Resources Department for the year 2022-2023 that as a IXth Phase, Repair, Renovation and Restoration of 100 tanks at an estimated cost of Rs.114.72 crore in 5 Districts namely, Dharmapuri, Krishnagiri, Tiruvannamalai, Ramanathapuram and Sivagangai Districts in the year 2022-2023 will be taken up.

2. In the letter read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has stated that a proposal for Repair, Renovation and Restoration (RRR) of 100 Tanks in 4 Districts namely, Kallakurichi, Ramanathapuram, Sivagangai and Virudhunagar under Phase IX was approved for an amount of Rs.10092.67 lakhs by the State Technical Advisory Committee (STAC) on 08.07.2022 and State Level Sanctioning Committee (SLSC) on 09.09.2022. The region wise details of tanks are as follows:-

Necessary action is being taken to submit the funding proposal along with all necessary authenticated certificates/ documents for the 100 water bodies of Phase IX to the Director (Mon), Central Water Commission, Chennai for forwarding to Ministry of Jal Shakti, New Delhi for inclusion of 100 water bodies under Repair, Renovation and Restoration scheme and for obtaining the Central Assistance from the Government of India. The works will be taken up for execution only after Central fund is released.

- 3. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has requested the Government to accord Administrative Sanction to take up Repair, Renovation and Restoration of 100 water bodies at an outlay of Rs.10092.67 lakhs under Phase IX of Har Khet Ko Pani component of PMKSY with Central State Share ratio 60 (Central-Rs.6055.60 lakhs): 40 (State-Rs.4037.07 lakhs).
- 4. The Government have decided to accept the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and hereby to accord Administrative Sanction to take up Repair, Renovation and Restoration of 100 water bodies of Water Resources Department at an outlay of Rs.100,92,67,000/- (Rupees One hundred crore ninety two lakhs and sixty seven thousand only) under Phase IX of Har Khet Ko Pani component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) with Central State Share ratio 60 (Central- Rs.6055.60 lakhs): 40 (State-Rs.4037.07 lakhs), as detailed at "annexure" to this order. Out of Rs.100,92,67,000/- financial sanction is accorded for a sum of Rs.30,27,80,000/- as central share and Rs.40,37,07,000/-as state share for the Financial Year 2022-23 and the balance amount of Rs.30,27,80,000/- will be released in the subsequent financial years based on the progress of civil works.
- 5. The expenditure sanctioned at para4 above shall be debited to the following head of account:-

Central Share- Rs. 3027.80 lakhs:

4711- Capital Outlay on Flood Control Projects- 01 Flood Control- 103 Civil Works-Schemes shared between State and Centre - UA Repair, Renovation and Restoration of Water Bodies - 416 Major Works - 01 Major Works.

State Share - Rs.4037.07 lakhs:

4711- Capital Outlay on Flood Control Projects- 01 Flood Control- 103 Civil Works-Schemes shared between State and Centre - UC Repair, Renovation and Restoration of Water Bodies - State Share - 416 Major Works - 01 Major Works.

6. Necessary additional funds of Rs.70,64,87,000/-will be provided in Revised Estimate / Final Modified Appropriation 2022 –2023. However, this expenditure shall be brought to the notice of Legislature by way of **Specific Inclusion** in the Supplementary Estimate 2022 –2023. Pending provision of such funds, the Engineer in Chief, Water Resources Department is authorized to incur the expenditure sanctioned in para 4 above. The Engineer-in-Chief, Water Resources Department, Chennai is directed to include the

above item of expenditure while sending the budget proposal for Revised Estimate / Final Modified Appropriation 2022 – 2023 and also send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimate 2022–2023 to Finance (PW-II/BG-I) Department at an appropriate time without fail.

7. The amount sanctioned in para 4 above shall be deposited to the Single Nodal Bank Account of the Tamil Nadu Water Resources Department as per the details given below:-
