



### **ABSTRACT**

Tamil Nadu Water Resources Department –Revised Administrative Sanction for a sum of Rs.9282.98 lakh including additional requirement of Rs.905.94 lakh under State Fund against original Administrative Sanction of Rs.8377.04 lakh to take up 100 Water Bodies under Phase VIII of Repair, Renovation and Restoration (RRR) Scheme under Har Khet Ko Pani component of Pradhan Mantri Krishi Sinchayee Yojana - Accorded – Orders- Issued.

### **ORDER:**

In the Government Order 1<sup>st</sup> as amended in Government Order 2<sup>nd</sup> read above, Administrative Sanction has been accorded to take up 100 Water Bodies at an outlay of Rs.8377.04 lakh under Phase VIII of Repair, Renovation and Restoration (RRR) Scheme under Har Khet Ko Pani (HKKP) component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) .

2. In the letter 3<sup>rd</sup> read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has stated that the estimates for the above works have been prepared by adopting the Schedule of Rates for the year 2021-22 with GST of 12%. The funding proposal was sent to Ministry of Jal Shakti through the Director (Mon), Central Water Commission, Chennai for inclusion and release of central assistance. In respect to RRR works, there should not be any deviation in the components or quantity specified in the DPR. Also, as per the RRR Guidelines, the total estimate cost at the time of inclusion will be frozen and only that estimate amount will be considered for calculating the central assistance (60%). Thus, the additional amount due to revision in Schedule of Rates and increase in GST has to be met out only from the State fund. Hence, the additional amount required due to revision in Schedule of Rates and GST is as follows :-

In addition to 40% share of State of Rs.3350.82 lakhs, an additional amount of Rs.905.94 lakhs have to be met out from the State fund, due to revision in Schedule of Rates and GST.

3. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has therefore requested the Government to accord Revised Administrative Sanction for a sum of Rs.9282.98 lakh including additional requirement of Rs.905.94 lakh under State Fund against original Administrative Sanction of Rs.8377.04 lakh to take up 100 Water Bodies under Phase VIII of Repair, Renovation and Restoration (RRR) Scheme under Har Khet Ko Pani (HKKP) component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY).

4. The Government have decided to accept the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and hereby to accord Revised Administrative Sanction for a sum of Rs.9282.98 lakh including additional amount of Rs.9,05,94,000/- (Rupees Nine Crore five lakh and ninety four thousand only) as additional State share under State Fund against original Administrative Sanction of Rs.8377.04 lakh to take up 100 Water Bodies under Phase VIII of Repair, Renovation and Restoration (RRR) Scheme under Har Khet Ko Pani (HKKP) component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY), as detailed at "Annexure" to this order.

5. The additional amount of Rs.905.94 lakh sanctioned at para 4 above shall be debited to the following head of account:-

4711- Capital Outlay on Flood Control Projects- 01 Flood Control- 103 Civil Works- Schemes shared between State and Centre - UC Repair, Renovation and Restoration of Water Bodies - State Share - 416 Major Works - 01 Major Works.

(IFHRMS DPC: 4711 01 103 UC 416 01)

6. Necessary additional funds of Rs.9,05,94,000/-will be provided in Revised Estimate / Final Modified Appropriation 2022 -2023. However, this expenditure shall be brought to the notice of Legislature by way of **Specific Inclusion** in the Supplementary Estimate 2022 -2023. Pending provision of such funds, the Engineer in Chief, Water Resources Department is authorized to incur the expenditure sanctioned in para 4 above. The Engineer-in-Chief, Water Resources Department, Chennai is directed to include the above item of expenditure while sending the budget proposal for Revised Estimate / Final Modified Appropriation 2022 - 2023 and also send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimate 2022-2023 to Finance (PW-II/BG-I) Department at an appropriate time without fail.

7. The amount sanctioned in para 4 above shall be deposited to the Single Nodal Bank Account of the Tamil Nadu Water Resources Department as per the details given below :-

9. It is also directed that a clear cut timeline for completion, involvement of the Farmers' Association and proper documentation can be done.
