#### **ORDER:**

In the Government Order first read above, the Government have accorded Administrative Sanction for providing emergency flood relief to the people residing in and around the flood plain areas of the Adyar River near Tambaram in Kancheepuram and Chengalpattu Districts at an estimated cost of Rs.70,05,10,000/- under the State Fund.

- 2. In the letter second cited, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has requested the Government to provide funds for a sum of Rs.5,50,000/- thousands for the Work of providing emergency flood relief to the people residing in and around the flood plain area of the Adyar River near Tambaram in Kancheepuram and Chengalpattu Districts.
- 3. The Government have examined the request of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and have decided to accept it. Accordingly, the Government hereby sanction a sum of Rs.55,00,00,000/- (Rupees Fifty five crore only) for the work of providing emergency flood relief to the people residing in and around the flood plain area of the Adyar River pending provision of funds in Final Modified Appropriation 2021-2022.
- 4. The expenditure sanctioned in para 3 above shall be debited under the following head of account:- (40-01)
  - "4701 Capital Outlay on Medium Irrigation -
  - 02 Chennai Basin 800 Other Expenditure -
  - State's Expenditure EA Water Course 416 Major Works -
  - 01 Major Works." (IFHRMS DPC.4701-02-800-EA-41601)

- 5. The expenditure sanctioned in para 3 above shall constitutes an item of "New Instrument of Services" and the approval of the Legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be met by drawal of an advance from the Contingency Fund. Orders regarding will be issued by Finance (BG-II) Department separately. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to send necessary proposals to Government in Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 with a copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate 2021 2022 to Finance (PW-II / BG-I) Department at an appropriate time.
- 6. This letter issues with the concurrence of Finance Department vide its U.O.No.37392/PW-II)/2021, dated.24.02.2022 and the Additional Sanctioned ledger No.1655 (One thousand six hundred and fifty five).
