Order:

In the Government Order first read above, sanction has been accorded for 36 posts of various categories including 18 posts of lower level staff to Tamil Nadu Water Resources Conservation and Rivers Restoration Corporation Limited with monthly consolidated pay as detailed below.:-

2. In the letter third read above, the Chairman-cum- Managing Director, TNWRC & RRC Ltd has stated that at present, 3 Nos. of Junior Assistant cum Data Entry Operators, 2 Nos. of Drivers, 1 No. of Office Assistant cum Driver, 2 Nos. of Office Assistant, 2 Nos. of Watchman and 1 No. of Sweeper (totally 11 persons) are being engaged to assist the day-today office work by outsourcing on the monthly payment of consolidated pay through contractor. The monthly consolidated pay is being paid to the outsourced personnel for the past 3 years.

- 3. The Chairman and Managing Director, TNWRC&RRC Ltd., has also stated that the Board of Directors on taking note of the information note in its 14th Board Meeting held on 24.01.2023 in respect of outsourced personnel, directed to ensure that the salary / remuneration payable to lower level staff being engaged through outsourcing is not less than the minimum rate of wages under the Minimum Wage Act and the same may be prescribed as one of the condition in the tender documents for outsourcing of man power to all the lower posts in future. Meanwhile, the outsourced persons have requested to increase their monthly consolidated pay considering the increase in cost of living.
- 4. The Chairman cum Managing Director, TNWRC&RRC, Chennai has also stated that (a) in the G.O. (2D) No.36, Labour Welfare and Skill Development (J1) Department, dated 16.06.2023, the Junior Assistant-cum-Data Entry Operator category has not been specified. Whereas, the category of Data Entry Operator has been specified as Grade-II of semi-skilled category and their minimum rate of wages for Data Entry Operator has been specified as Rs.14,000/- and the total wages have been worked out to Rs.19,022/-, but the existing consolidated pay for the post of Junior Assistant-cum-Data Entry Operator has been fixed as Rs.20,000/- vide G.O.(Ms) No.10, Public Works (WR1) Department, dated 6.1.2020. Hence, the Junior Assistantcum-Data Entry Operators may be considered as Semi-skilled Grade-I as indicated in the G.O. (2D) No.36, Labour Welfare and Skill Development (J1) Department, dated 16.06.2023 and the minimum rate of wages for Junior Assistant-cum-Data Entry Operator may be specified as Rs.15,000/- (b) the Drivers (HMV/LMV) and the Office -Assistant- cum- Driver were classified under the category of Semi-skilled, Grade-I and minimum rate of wage has been specified as Rs.15,000/-(c) the Office Assistant, Watchman and Sweeper are classified under the unskilled category and their minimum basic wages are specified as Rs.13,000/- (d) accordingly, the wages along with DA of the outsourcing staff have been worked out as per the G.O.(2D) No.36, Labour Welfare and Skill Development (J1) Department, dated 16.6.2023 as detailed below:-

- 5. The Chairman and Managing Director, Tamil Nadu Water Resources Conservation and Rivers Restoration Corporation Limited (TNWRC&RRC) has therefore requested the Government to sanction the minimum rate of wage to the contract employees in TNWRC&RRC as indicated at para4 above and to direct the Board of Directors, TNWRC&RRC to adopt and change wages with respect to the revised minimum wages with effect from 01.01.2024.
- 6. The Government after careful examination have decided to accept the proposal of the Chairman-cum-Managing Director, TNWRC & RRC Ltd., and hereby accord sanction for the minimum rate of wage to the contract employees in TNWRC&RRC as indicated at para4 above .The Government have also directed the Board of Directors, TNWRC&RRC to adopt and change wages with respect to the revised minimum wages with effect from 01.01.2024. Also, it is pointed out that as result of this sanction, the additional cost to TNWRC&RRC would be Rs.5.47 lakhs per annum + Service Charges (as per tender) + 18% GST.
- 7. This order issues with the concurrence of the Finance Department vide its U.O.No. efile /2216/WR1/2023,dt:08.02.2024.
