ORDER:

In the Government Order 1st read above, the Government have accorded administrative sanction for the work of Construction of Bridges across small rivers in Virudhunagar and Coimbatore Districts at an estimated cost of Rs.5,74,47,000/-.

2. Due to revision of GST rate, in the letter 2nd read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has sent a proposal for Revised Administrative Sanction for administrative sanction for Construction of Bridges across small rivers in Virudhunagar and Coimbatore Districts at an estimated cost of Rs.5,99,63,221/- and furnished following details.

- i. Based on the above Government Order, the Chief Engineer and Superintending Engineer concerned have accorded technical sanction for the above works and the same were also entrusted to the intended contractors for execution.
- ii. Based on the revision of GST Rate, the Chief Engineer, Madurai Region, Water Resources Department, Madurai has furnished a Revised Administrative Sanction

proposals requesting an approval from the Government for various scenes of works supported by the State funded works & TNIAMP with reference to the above mentioning and orders.

- iii. After scrutinizing the proposals, the excess amount occurred to due to GST revision implementation only, which couldn't be accommodated in the Administrative Sanction amount.
- iv. During the 60th meeting of Technical Advisory Committee held on 25.04.2023 the committee has recommended. The proposals had also been placed and approved 24th meeting of Tender Award Committee held on 28.04.2023.

3. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department has requested that the Revised Administration Sanction amount of Rs.5,99,63,221/- for the following works with an excess of Rs.25,16,221/- over the administrative sanction amount of Rs.5,74,47,000/-.

Based on the recommendations of the Technical Advisory Committee and Tender Award Committee, the Government after careful examination, have decided to accept the proposal of the Engineer-in- Chief and Chief Engineer (General), Water Resources Department, Chennai and accordingly, Revised Administrative Sanction is accorded for Construction of Bridges across small rivers in Virudhunagar and Coimbatore Districts at an estimated cost of Rs.5,99,63,221/- (Rupees Five Crore ninety nine lakh sixty three thousand two hundred and twenty one only) for the above works with an excess of Rs.25,16,221/- over and above the original administrative sanction amount of Rs.5,74,47,000/- which has already been accorded in G.O.(4D) No.41, Water Resources (S1) Department, dated 30.05.2022.

5. The additional expenditure sanctioned in para 4 above shall be debited to the following head of account: (40-01)

The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to include the above item of expenditure while sending the budget proposal for Revised Estimate / Final Modified Appropriation 2023 - 2024 and also send necessary draft Explanatory Notes for Inclusion of the expenditure in the Supplementary Estimate 2023 - 2024 to Finance (Infra-II / BG-I) Department at an appropriate time without fail.
