ORDER:

During the Demand for Grants for Water Resources Department for the year 2022-2023 held on 06.04.2022, the Hon'ble Minister (Water Resources) on the floor of the Assembly has announced that "Rehabilitation works of 14 Irrigation Structures in 7 Districts" will be taken up at an estimated cost of Rs. 251.00 crore.

- 2. Based on the above announcement, the Chief Engineer, Plan Formulation, Water Resources Department has sent a proposal for Restoration of Elumpallam tank in Mannavanur Village of Kodaikanal Taluk in Dindigul District at an estimated cost of Rs.1.40 Crore and the Scheme envisages the following:
 - (i) The Elumpallam Tank is situated in Mannavanur Village of Kodaikanal Taluk in Dindigul District.
 - (ii) The main source of this tank is the catchment area of Kodaikanal hills around Mannavanur forest area.
 - (iii) The Elumpallam tank is a non system tank. It is located in Mannavanur village of Kodaikkanal Taluk. The registered ayacut of this tank is 530.78 acre. The total length of the bund is 90 m and the weir length is 15.00 m.

(iv) Hydraulic particulars of Elumpallam tank

Capacity : 3.48 Mcft. Ayacut : 530.78 Acre.

No. of Sluice : 1No.
Weir Length : 15.00 m.
Bund length : 90 m

- (v) The surplus weir, sluice and the tank bund are in damaged condition. The water stored in this tank is getting leaked through this damaged sluice and through the weak portion of bund. Hence it is necessary to rehabilitate the weir, sluice and bund for effective storage of water for irrigation purpose. By implementing this scheme, an ayacut of 530.78 acres will get stabilized.
- (vi) The estimate has been prepared with the following provisions.
 - a) Construction of Protection wall for the entire length of bund.
 - b) Construction of cut off in U/S and D/S of weir.
 - c) Construction of skin wall for weir.
 - d) Repairs to sluice.
 - e) Construction of Field channel
- 3. The Chief Engineer, Plan Formulation, Water Resources Department, has stated that the estimates have been prepared based on the Schedule of Rates for 2021- 2022 and mandatory lump sum provisions have been made in the detailed estimates and requested to accord Administrative Sanction for Restoration of Elumpallam Tank in Mannavanur Village of Kodaikanal Taluk in Dindigul District at an estimated cost of Rs.1.40 Crore.
- 4. The Government after careful examination, have decided to accept the above proposal of the Chief Engineer, Plan Formulation, Water Resources Department by restricting the cost of the Works to Rs.1,37,00,000/-. Accordingly, administrative sanction is accorded for Restoration of Elumpallam Tank in Mannavanur Village of Kodaikanal Taluk in Dindigul District at an estimated cost of Rs.1,37,00,000/- (Rupees One crore and thirty seven lakh only).
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:- (40-01)

4700 - Major Irrigation - 05 - Vaigai Basin - 800 - Other Expenditure State's Expenditure - AA - Reservoir - 416 - Major Works - 01 Major Works.

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Services" and the approval of the Legislature will be obtained in due course. Pending approval of the legislature, the expenditure initially will be met by drawal of an advance from the Contingency Fund. Orders regarding which will be issued by Finance (BG-I) Department separately. The Engineer-in-Chief and Chief Engineer

(General), Water Resources Department, Chennai is directed to send necessary proposal to Government in Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary Explanatory Notes for inclusion of the above expenditure in the Supplementary Estimate 2022-2023 to Finance (PW-II / BG-I) Department at an appropriate time without fail.

- 7. It is also directed that the details of works executed must be uploaded in the Tamil Nadu Water Resources Information and Management Systems Portal under the Control of Chief Engineer, Institute of Water Studies, Hydrology and Quality Control to ensure effective data base in the Water Resources Department.
- 8. This order issues with the concurrence of Finance Department vide its U.O. No.28273/PW-II/2022, dated 09.06.2022 and Additional Sanction Ledger No.351 (Three hundred and fifty one).
