Water Resources Department – premature condemnation of the vehicles Jeep TN 04 G 0425, Omni Bus (Jeep) TN 20 G 0013 and Jeep TN 04 G 0409 pertaining to Functional Chief Engineers – Sanction accorded – Orders issued.

In the letter read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has submitted the proposal for premature condemnation of the vehicles Jeep TN 04 G 0425, Omni Bus (Jeep) TN 20 G 0013 and Jeep TN 04 G 0409 pertaining to Functional Chief Engineers.

2. The premature condemnation of the above vehicles are consolidated as below:-

I. Jeep TN 04 G 0425

The Technical Committee has reported that expenditure on repairing of maintaining this vehicle comes to Rs.3,46,000/-. The cost of repairs to bring this vehicle to road worthy condition is very much higher than the value of Rs.15,700/- (Rupees fifteen thousand and seven hundred only) as per present condition of the vehicle. This vehicle Jeep TN-04-G-0425 has served for 23 years which is less than the prescribed period of 10 years and covered 2,30,967 km only against the prescribed kilometers of 2,50,000 km for Diesel driven vehicle as per the norms for condemnation issued vide G.O. (Ms) No.2275, Home (Transport-E) Department, dated 10.10.1990.

II. Omni Bus (Jeep) TN-20-G-0013

The Technical Committee has reported that expenditure on repairing of maintaining this vehicle comes to Rs.3,36,500/-. The cost of repairs to bring this vehicle to road worthy condition is very much higher than the value of Rs.21,100/- (Rupees twenty one thousand and one hundred only) as per present condition of the vehicle. This vehicle Omni Bus (Jeep) TN-20-G-0013 has served for 25 years which is more than the prescribed period of 10 years and covered 2,26,811 km only against the prescribed

kilometers of 2,50,000 km for Diesel driven vehicle as per the norms for condemnation issued vide G.O. (Ms) No.2275, Home (Transport-E) Department, dated 10.10.1990.

III. Jeep TN-04-G-0409

The Technical Committee has reported that expenditure on repairing of maintaining this vehicle comes to Rs.3,52,000/-. The cost of repairs to bring this vehicle to road worthy condition is very much higher than the value of Rs.16,700/- (Rupees sixteen thousand and seven hundred only) as per present condition of the vehicle. This vehicle Jeep TN-04-G-0409 has served for 21 years which is more than the prescribed period of 10 years and covered 2,12,138 km only against the prescribed kilometers of 2,50,000 km for Diesel driven vehicle as per the norms for condemnation issued vide G.O. (Ms) No.2275, Home (Transport-E) Department, dated 10.10.1990.

- 3. The Single Technical Committee and the Chief Engineer, Water Resources Department, Operation and Maintenance, Chennai have recommended the premature condemnation of the above vehicles.
- 4. Based on the recommendation, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has requested the Government to accord sanction for premature condemnation of the vehicles Jeep TN 04 G 0425, Omni Bus (Jeep) TN 20 G 0013 and Jeep TN 04 G 0409 pertaining to Functional Chief Engineers.
- 5. The Government after careful consideration have decided to accept the request of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai. Accordingly, sanction is accorded for premature condemnation of the vehicles Jeep TN 04 G 0425, Omni Bus (Jeep) TN 20 G 0013 and Jeep TN 04 G 0409 pertaining to Functional Chief Engineers.
