ORDER:

In the Government Order first read above, Administrative Sanction was accorded for Environment Impact Assessment Study and preparation of Detailed Project Report for excavation of new flood carrier canal each in Tirunelveli and Thoothukudi Districts at an estimated cost of Rs.1.60 crore as follows:

2. In the letter 2nd read above, the Chief Engineer, Plan Formulation, Water Resources Department, has sent a proposal for according Revised Administrative Sanction for Environment Impact Assessment Study and preparation of detailed estimate for excavation of new flood carrier canal each in Tirunelveli and Thoothukudi Districts at an estimated cost of Rs.1.6145 crore, against administrative sanction of Rs.1.60 Crore accorded in the Government Order first read above, as follows:

- i While preparing the proposal for 'Construction of a Diversion Weir across Nambiyar river and Excavation a new canal to divert the flood water to Kuttam and surrounding areas in Thisaiyanvilai Taluk of Tirunelveli District', it was presumed that the preparation of Detailed Project Report, Environment Impact Assessment Studies and its Clearance work will be entrusted to M/s WAPCOS as a single source. Therefore, provision for advertisement charge was not made in the estimate.
- ii But in the above Government order it has been instructed that the selection of Consultancy should be based on procurement guidelines. Hence, advertisement charges for the above scheme is necessary for selection of consultancy.
- iii Hence, revised estimate including advertisement charges as per the norms prescribed in G.O (Ms) No.103, Finance (Salaries) Department, dated 11.04.2022 have been prepared.
- iv Accordingly, based on the above revised norms, advertisement charges for preparation of Detailed Project Report, Environment Impact Assessment Studies and its Clearance work for the above scheme has been included in the estimate.

3. The Chief Engineer, Plan Formulation, Water Resources Department, Chennai has requested to accord Revised Administrative Sanction for preparation of Detailed Project Report, Environmental Impact Study and Environmental Clearance for the above 2 schemes for an amount of Rs.1.6145 Crore.

4. The Government, after careful examination, have decided to accept the proposal of the Chief Engineer, Plan Formulation, Water Resources Department, Chennai. Accordingly, Revised Administrative Sanction is accorded for Environment Impact Assessment Study and

preparation of Detailed Estimate for excavation of new flood carrier canal each in Tirunelveli and Thoothukudi Districts at an estimated cost of Rs.1.6145 crore (Rupees One crore, sixty one lakh and forty five thousand only) against administrative sanction accorded for Rs.1.60 Crore in the Government Order first read above which is in excess of Rs.1.45 lakh towards Advertisement Charges as follows:
