ORDER:

In the Government Order 1st read above, the Government have accorded administrative sanction and financial sanction Flood Protection Works to Kadambakulam surplus course, Marudur Melakal in Thoothukudi District at an estimated cost of Rs.34,61,44,936/- under NABARD loan assistance under RIDF XXVIII for 2022 - 2023.

2. Due to revision of GST rate, in the letter 2nd read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has sent a proposal for Revised Administrative Sanction for Flood Protection Works to Kadambakulam surplus course, Marudur Melakal in Thoothukudi District for Rs.36,43,60,000/- and furnished following details.

- i. The Chief Engineer, Madurai Region, Water Resources Department, Madurai has furnished the proposals requesting an approval from the Government in the shape of Revised Administrative Sanction for Flood Protection Works to Kadambakulam surplus course, Marudur Melakal in

Thoothukudi District at an estimated cost of Rs.36,43,60,000/-. After scrutinizing the proposals, the excess amount occurred to due to GST revision implementation. It leads to RAS which causing couldn't restrict and prevent within the Administrative Sanction amount.

- ii. By observing the notions and detailed deliberations, the proposal get placed before the 60th meeting of Technical Advisory Committee held on 25.04.2023 and obtained recommendations to approve and suggested to place the Tender Award Committee. The proposals had been placed and approved in the 24th meeting of Tender Award Committee held on 28.04.2023 for the amount of Rs.36,43,60,000/- for the above works with an excess of Rs.1,82,15,064/- over the administrative sanction amount of Rs.34,61,44,936/-.

3. With the above details, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has requested the Revised Administration Sanction amount of Rs.36,43,60,000/- for the above scheme as detailed below with an excess of Rs.1,82,15,064/- over the administrative sanction amount of Rs.34,61,44,936/- may be obtained and communicated to this office for further necessary action as follows:

Based on the recommendations of the Technical Advisory Committee and Tender Award Committee, the Government after careful examination, have decided to accept the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and accordingly, Revised Administrative Sanction is accorded for Flood Protection Works to Kadambakulam surplus course, Marudur Melakal in Thoothukudi District at an estimated cost of Rs.36,43,60,000/- (Rupees Thirty six crore, forty three lakh and sixty thousand only) with an excess of Rs.1,82,15,064/- over and above the Administrative Sanctioned

amount of Rs.34,61,44,936/- which has already been accorded in G.O (Ms) No.51, Water Resources (S2) Department, Dated.28.06.2022.

5. The additional expenditure sanctioned in para 4 above shall be debited to the following head of account: (40-01)

6. The expenditure sanctioned in para 4 above shall constitutes an item of "New Instrument of Services" and the approval of the Legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be met by drawl of an advance from the Contingency Fund. Orders regarding which will be issued by Finance (BG-I) Department separately. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai-5 is directed to send necessary proposals to Government in Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 with a copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate 2023 - 2024 to Finance (Infrastructure-II / BG-I Department at an appropriate time.
