From the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai-5 Letter No. S7 (1) / 68809E / 0T5 / 2023-1, dated 17.08.2023.

Order:

In the letter read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has submitted a proposal for 10 Nos. of flood mitigation works at an estimated cost of Rs.249.00 lakh in Chennai, Kancheepuram and Thiruvallur Districts.

2. Based on the request of the Chief Engineer, Chennai Region, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has stated that during the inspection of the Hon'ble Chief Minister in the Red Hills and Chembarambakkam Lake on 20.10.2021, it has been instructed to clear all the water hyacinth and unwanted vegetations in the City water supply bodies and to desilt the Channels before the onset of the monsoon to attain zero flooding in Chennai City and its surrounding.

3. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has further stated that the following works are to be taken up for the financial year 2023-2024, to clear the water hyacinth and unwanted vegetations to avoid the flooding and free flow of flood water during the onset of monsoon:-

This Detailed Estimates have been prepared based on the Current Schedule of Rates for the year 2023 - 2024.

4. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has therefore recommended the proposal of the Chief Engineer, Water Resources Department, Chennai Region, Chennai and requested the Government to accord sanction for 10 Nos. of flood mitigation works at an estimated cost of Rs.249.00 lakh in Chennai, Kancheepuram and Thiruvallur Districts.

5. The Government, after careful examination, have decided to accept the request of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai, and hereby accord Administrative and Financial Sanction for 10 Nos. of flood mitigation works at an estimated cost of Rs.2,49,00,000/- (Rupees two crore and forty nine lakh only) in Chennai, Kancheepuram and Thiruvallur Districts.

6. The expenditure sanctioned at para 5 above shall be debited to the following head of account:-

4711 Capital outlay on Flood Control Project - 01 Flood Control — 103 Civil Works State's Expenditure - KO Desilting, Widening and Construction of Flood Protection Works in Chennai City Water Ways — 416 Major Works - 01 Major works

7. Necessary additional funs of Rs.2,49,00,000/- will be provided in RE / FMA 2023-2024. However, this expenditure shall be brought to the

notice of legislature by way of Specific Inclusion in the Supplementary Estimate 2023-2024. Pending provision of funds, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is authorized to incur the expenditure sanction in para 5 above. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to include the above item of expenditure while sending the budget proposal for RE / FMA 2023-2024 and also send necessary draft Explanatory note for inclusion of the expenditure in the Supplementary Estimate 2023-2024 to Finance (Infrastructure-II / BG-I) Department at an appropriate time without fail.

8. The details of works executed must be uploaded in the Tamil Nadu Water Resources Information and Management Systems Portal Under the Control of Chief Engineer, Institute of Water Studies, Hydrology and Quality Control to ensure effective data base in the Water Resources Department.

9. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai are therefore directed to ensure the designs, drawings and description of work prescribed in the estimate should be same while according Technical Sanction.
