ORDER:

In the Government Order 1st read above, the Government have accorded administrative sanction and financial sanction for Rehabilitation of 50 Minor Irrigation Tanks in Sivagangai and Tiruppur Districts at an estimated cost of Rs.32,42,74,000/-

2. Due to revision of GST rate, in the letter 2nd read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has sent a proposal for Revised Administrative Sanction for 42 Ex- Zamin Tanks in Sivagangai District for Rs.25.33 Crore and furnished following details.

- i. The Chief Engineer, Madurai Region, Water Resources Department, Madurai has furnished the proposals requesting an approval from the Government in the shape of Revised Administrative Sanction wherein standardisation of 42 Ex-zamin Tank works also included out of 50 minor irrigation tank worked out of Rs.24.14 crore. After scrutinizing the proposals, the excess amount occurred to due to GST revision implementation. It leads to RAS which causing couldn't restrict and prevent within the Administrative Sanction amount.
- ii. By observing the notions and detailed deliberations, the proposal get placed before the 60th meeting of Technical

Advisory Committee held on 25.04.2023 and obtained recommendations to approve and suggested to place the Tender Award Committee. The proposals had been placed and approved in the 24th meeting of Tender Award Committee held on 28.04.2023 for the amount of Rs.25,33,83,010/- over the administrative sanction allotted to the above 42 works of Rs.24,14,00,000/- with an excess of Rs.1,19,83,010/-

3. With the above details, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has requested the Revised Administration Sanction amount of Rs.33,62,57,010/- for the above scheme as detailed below with an excess of Rs.1,19,83,010/- (i.e.4.96% overall excess) over the administrative sanction amount of Rs.32,42,74,000/- may be obtained and communicated to this office for further necessary action.

4. Based on the recommendations of the Technical Advisory Committee and Tender Award Committee, the Government after careful examination, have decided to accept the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and accordingly, Revised Administrative Sanction is accorded for Standardisation of 50 Minor Irrigation Tanks in Sivagangai and Tiruppur Districts at an estimated cost of Rs.33,62,57,010/- (Rupees Thirty three crore sixty two lakh fifty seven thousand and ten only) with an excess of Rs.1,19,83,010/- over and above the Administrative Sanction of Rs.32,42,74,000/- which has been accorded in G.O (Ms) No.45, Water Resources (S2) Department, Dated: 23.06.2022, in Revised Administrative Sanction a sum of Rs.25,33,83,010/- (Rupees Twenty five crore thirty three lakh eighty three thousand and ten only) for 42 Ex-zamin Tanks in Sivagangai District and Rs.8,28,74,000/- for 8 tanks in Tiruppur District, as in para 3 above.

The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to include the above item of expenditure while sending the budget proposal for Revised Estimate / Final Modified Appropriation 2023 – 2024 and also send necessary draft Explanatory Notes for Inclusion of the expenditure in the Supplementary Estimate 2023 – 2024

to Finance (Infra-II / BG-I) Department at an appropriate time without fail.
