#### **ORDER:**

In the Government Order 1st read above, the Government have accorded administrative sanction for the work of Excavation of a New Link Canal from Urmelalagiyan Tank to Karunkulam Tank in Kadayanallur Taluk of Tenkasi District at an estimated cost of Rs.1,96,83,000/-.

- 2. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, in his letter 2nd read above, has sent a proposal for Revised Administrative Sanction for the work of Excavation of a New Link Canal from Urmelalagiyan Tank to Karunkulam Tank in Kadayanallur Taluk of Tenkasi District at an estimated cost of Rs.2,03,49,368/- and furnished following details:
  - i. Based on the above Government Order, the Chief Engineer, Water Resources Department, Madurai Region has accorded technical sanction for the above work and the same were also entrusted to the intended contractor for execution.
  - ii. The 47th GST council meeting held on 28th and 29th of June 2022 had decided to revise the rates of GST for the works contracts supplied to Central or State Government from 5% to 12% predominantly for Earthwork excavation and 12% to 18%

for rest of works and subsequently, the Government had amended the revision of rates of GST vide G.O.(Ms) No.114, Commercial Taxes and Registration Department, dated 22.7.2022 for works contract supplied to Central and State Government, Local Authorities for historical monuments, canals dams, pipelines, plants for water supply educational institutions hospitals etc., and sub contract thereof, the rate of GST revised from 12% to 18% with effect from 18.07.2022.

- iii. Based on the revision of GST Rate, the Chief Engineer, Madurai Region, Water Resources Department, Madurai has furnished a RAS proposal for the above work and requesting an approval from the Government.
- iv. After scrutinizing the proposals, the excess amount occurred due to revision of GST implementation only, which couldn't be accommodated in the amount of administrative Sanction.
- v. By observing the notions and detailed deliberations, this proposal placed before the 60th meeting of Technical Advisory Committee held on 25.04.2023 and committee has recommended this work to approve and suggested to place the Tender Award Committee.

The proposals had been placed and approved in the 24th meeting of Tender Award Committee held on 28.04.2023.

- 3. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department has requested to accord Revised Administration Sanction for the work of Excavation of a New Link Canal from Urmelalagiyan Tank to Karunkulam Tank in Kadayanallur Taluk of Tenkasi District for Rs.2,03,49,368/- with an excess of Rs.6,66,368/- over the administrative sanction of Rs.1,96,83,000/-.
- 4. Based on the recommendations of the Technical Advisory Committee and Tender Award Committee, the Government after careful examination, have decided to accept the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and accordingly, Revised Administrative Sanction is accorded for work of Excavation of a New Link Canal from Urmelalagiyan Tank to Karunkulam Tank in Kadayanallur Taluk of Tenkasi District at an estimated cost of Rs.2,03,49,368/- (Rupees Two crore three lakh forty nine thousand three hundred and sixty eight only) with an excess of Rs.6,66,368/- over the administrative sanction amount of Rs.1,96,83,000/-
- 5. The additional expenditure sanctioned in para 4 above shall be debited to the following head of account: (40 01)

4700 Capital Outlay on Major Irrigation — 05 Vaigai Basin — 800 Other Expenditure — State's Expenditure — EA Water Courses - 416 Major works — 01 Major Works.

6. Necessary funds of Rs.6,66,368/- will be provided in Revised Estimate / Final Modified Appropriation 2023 – 2024 to meet the

expenditure sanctioned in para-4 above. Pending provision of such funds the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is authorized to incur the expenditure sanctioned para 4 above and he is requested to include the expenditure sanctioned above, while sending the Budget proposal for Revised Estimate / Final Modified Appropriation to Finance (Infra-II / BG-I) Department without fail

7. This order issues with the concurrence of the Finance Department vide its U.O. No.5032/Infra-II/2023, dated.21.11.2023 and Additional Sanction Ledger No.1338 (One thousand three hundred and thirty eight) (IFHRMS ASL No. 2023111338).
