### **ORDER:**

In the Government Order 1<sup>st</sup> read above, administrative sanction has been accorded for Formation of a new Tank in Kasthuriengapuram Part-II Village in Tisaiyanvilai Taluk of Tirunelveli District at an estimated cost of Rs.4,68,70,590/-

2. Due to revision of GST rate, in the letter 2<sup>nd</sup> read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has sent a proposal for Revised Administrative Sanction for Formation of a new Tank in Kasthuriengapuram Part-II Village in Tisaiyanvilai Taluk of Tirunelveli District at an estimated cost of Rs.4,84,40,000/- and furnished following details :

- i. The Chief Engineer, Madurai Region, Water Resources Department, Madurai has furnished the proposals requesting an approval from the Government in the shape of Revised Administrative Sanction wherein Formation of a new Tank in Kasthuriengapuram Part-II Village in Tisaiyanvilai Taluk of Tirunelveli District at an estimated cost of Rs.4,84,40,000/-. After scrutinizing the proposals, the excess amount occurred to due to GST revision implementation. It leads to RAS which causing couldn't restrict and prevent within the Administrative Sanction amount.
- ii. By observing the notions and detailed deliberations, the proposal placed before the 60th meeting of Technical Advisory Committee held on 25.04.2023 and received recommendations for 122 works

including above works to approve and suggested to place the Tender Award Committee including in Sl. No.111. The proposals had been placed and approved in the 24<sup>th</sup> meeting of Tender Award Committee held on 28.04.2023 and also recommended 118 works including the Sl.No.115.

3. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department has requested the Revised Administration Sanction amount of Rs.4,84,40,000/- for the above scheme with an excess of Rs.15,69,410/- over the administrative sanction amount of Rs.4,68,70,590/- as follows :

4. Based on the recommendations of the Technical Advisory Committee and Tender Award Committee, the Government after careful examination, have decided to accept the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and accordingly, Revised Administrative Sanction is accorded for Formation of a new Tank in Kasthuriengapuram Part-II Village in Tisaiyanvilai Taluk of Tirunelveli District at an estimated cost of Rs.4,84,40,000/- (Rupees Four Crore eighty four lakh and forty thousand only) for the above work with an excess of Rs.15,69,410/- over and above the original administrative sanction amount of Rs.4,68,70,590/- which has already been accorded in G.O.(Ms)No.36, Water Resources (S2)Department, dated 30.05.2022.

5. The additional expenditure sanctioned in para 4 above shall be debited to the following head of account: (40-01)

4701 - Capital Outlay on Medium Irrigation —  
 01 - Thamirabarani Basin — 800 Other Expenditure —  
 State's Expenditure — EA Water Course -  
 416 Major works — 01 Major Works.

6. Necessary additional funds of Rs.15,69,410/- will be provided in Revised Estimate / Final Modified Appropriation 2023 - 2024. However, this expenditure shall be brought to the notice of legislature by way of Specific Inclusion in the Supplementary Estimates 2023 - 2024. Pending provision of such funds, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is authorized to incur the expenditure sanctioned in para 4 above. The Engineer-in-Chief and Chief Engineer (General), Water Resources



Department, Chennai is directed to include the above item of expenditure while sending the budget proposal for Revised Estimate / Final Modified Appropriation 2023 – 2024 and also send necessary draft Explanatory Notes for Inclusion of the expenditure in the Supplementary Estimate 2023 – 2024 to Finance (Infra-II / BG-I) Department at an appropriate time without fail.
