ORDER:

In the Government Order first read above, block administrative sanction has been accorded for a sum of Rs.2962 Crore (455.80 Million US Dollar including the fund assistance of 318 million US Dollar from the World Bank at the exchange rate of Rs.64.98 per US Dollar) for Tamil Nadu Irrigated Agriculture Modernization Project with a project period of 7 years from 2017 to 2024. As mentioned in the above said Government Order among others, the fund allocation for the Tamil Nadu Agriculture University and the Animal Husbandry Department are as below:-

Veterinary and Animal Sciences University from the outlay of Rs.87.46 crore of Tamil Nadu Agriculture University. Subsequently NOC of the World Bank for the Detailed Project Report (DPR) of Tamil Nadu Veterinary and Animal Sciences University for Rs.2.00crore was received.

3. The Project Director, TN IAM Project, MDPU, Chennai has therefore requested the Government to accord acceptance for the reallocation of fund from Tamil Nadu Agriculture University to Tamil Nadu Veterinary and Animal Sciences University as detailed below:-
