



### **ABSTRACT**

Water Resources Department – World Bank - TNIAMP- Administrative Sanction to take up the works in Nandhiyar Kulaiyar Sub basin at an estimated cost of Rs.74.30 crore under phase IV of World Bank funded TN IAMP-Accorded – Orders- Issued.

### **ORDER:-**

In the Government Order first read above, administrative sanction has been accorded for a sum of Rs.272.18 crore to take up the works for 21 packages in 8 sub basins viz., Lower Vellar, Thurinjalar, Poiney, Lower Coleroon, Sathaiyar, Therkkar, Lower Vaigai and Aliyar sub basin out of 10 sub basins under Phase IV of World Bank assisted Tamil Nadu Irrigated Agriculture Modernisation Project, as a part of Phase IV.

2. In the letter 2<sup>nd</sup> read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has informed to the Project Director, TNIAMP as follows:-

- I. Out of the remaining 2 sub basins (Cauvery Delta Sub basin and Nandhiyar Kulaiyar Sub basin) in Phase-IV of TNIAMP in Trichy Region the following components of works are included in Nandhiyar Kulaiyar Sub basin in 6 main canals to a length of 121.87 km with a total ayacut of 15051.31 ha including gap of 3867.46 ha.

1.	Reconstruction of sluice	-	130 nos.
2.	Length of lining	-	910 m
3.	Bund strengthening	-	23.10 km
4.	Construction of protection wall	-	200 m

- II. Most of the irrigation structures are in dilapidated condition and it is necessary to complete the works before the commencement of irrigation period (i.e) First week of June 2023 to achieve uninterrupted flow in channels and to meet the farmers demand of water for irrigation. The above works could be implemented during non-irrigation season (28<sup>th</sup> January to 12<sup>th</sup> June) and only 5 month period is available for execution of the above works. Before

commencement of the above works, procurement plan approval from World Bank and tender processing works including contract finalization will consume more than 3 months.

- III. The total cost of "Rehabilitation of the channels including Environmental Component, L.S. provision at 3.5%, GST at 18% and On Farm Development (OFD) Works comprising of 2packages in Nandhiyar Kulaiyar sub-basin is worked out to Rs.74.30crore, covering 0.15 lakh hectare. The detailed estimates of the packages have been prepared based on the Schedule of Rates for the year 2022-2023.
- IV. Administrative sanction may be obtained for Nandhiyar Kulaiyar Sub basin at a cost of Rs.74.30 crore on priority basis and to take up the work at the earliest. The fund of Rs.74.30crore required for Nandhiyar Kulaiyar sub basin is well with in the balance of Rs.218.48 crore arising out of block administrative sanction of Rs.2131.34 crore.

3. In the letter third read above, the Project Director, TNIAMP, MDPU, Chennai has stated that the World Bank has given its approval for the estimate cost of Rs.74.30 crore for the work of Nandhiyar Kulaiyar Sub basin.

4. The Project Director, TNIAMP, MDPU Office, Chennai has therefore requested the Government to accord administrative sanction to take up works in the Nandhiyar Kulaiyar sub basin at estimated cost of Rs.74.30 Crore under phase IV of TNIAMP.

5. The Government have decided to accept the proposal of the Project Director, TNIAMP, MDPU, Chennai and hereby accord administrative sanction to take up works in Nandhiyar Kulaiyar Sub basin at an estimated cost of Rs.74.30 crore (Rupees Seventy four crore and thirty lakh only) under phase IV of World Bank funded TN IAMP,as detailed below:-

7. The expenditure sanctioned in para 5 above shall constitute an item of "New Instrument of Services" and the approval of the Legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be met by drawl of an advance from the Contingency Fund. Orders regarding which will be issued by Finance (BG-I) Department Separately. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to send necessary proposals to Government in Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate 2023-2024 to Finance (PW-II/ BG-I) Department at an appropriate time.
