ORDER:

In the Government Order 1st read above, the Government have permitted the Tamil Nadu Water Resources Conservation and Rivers

Restoration Corporation Limited to apply to NABARD under NABARD Infrastructure Development Assistance (NIDA) seeking Loan Assistance for the Work of Extension, Renovation and Modernisation of the Lower Bhavani Project System at an estimated cost of Rs.933.10 crore.

2. In the Government Order 2nd read above, the Government have accorded sanction for the Work of Extension, Renovation and Modernisation of the Lower Bhavani Sub Basin Irrigation system at an estimated cost of Rs.933.10 crore, in anticipation of loan assistance for NABARD under NIDA and also accorded sanction to the Tamil Nadu Water Resources Conservation and Rivers Restoration Corporation Limited to entrust the Work to the Chief Engineer, Coimbatore Region, Water Resources Department as a deposit work and for splitting up the following Work into six packages:

3. In this regard, NABARD have communicated the sanction of a term loan of Rs.839.79 crore (90% of the project cost) and requested the acceptance of the Corporation for the above term loan along with Terms and Conditions. Based on the acceptance of terms and conditions of NABARD, the loan of Rs.839.79 crore has been sanctioned by NABARD under NIDA to Tamil Nadu Water Resources Conservation and Rivers Restoration Corporation Limited for execution of the above Work.

- 4. Accordingly, in the Government Order 3rd read above, the Government have issued unconditional and irrevocable Government Guarantee to the Tamil Nadu Water Resources Conservation and Rivers Corporation Restoration Limited for the Principal of Rs.839.79 Crore (Rupees Eight Hundred and Thirty Nine Crore and Seventy Nine Lakh only) along with the interest thereon sanctioned by NABARD under NIDA along with the General and Specific Terms and Conditions for the NIDA loan and the remaining 10% of the project cost i.e., Rs.93.31 Crore (Rupees Ninety Three crore and Thirty One Lakh only) is to be borne by the State Government, subject to the condition that the Engineer in Chief, Water Resources Department and Chief Engineer (General), Public Works Department shall monitor and review the prompt debt servicing of the guaranteed loan by the Tamil Nadu Water Resources Conservation and Rivers Restoration Corporation Limited and also ensure remittance of Guarantee fee due to the Government on The Government have also directed the Tamil Nadu Water Resources Conservation and Rivers Restoration Corporation Limited to pay Guarantee Fee of 0.50% (half percent) per annum of the total guaranteed amount / outstanding Guarantee together with interest payable from time to time into the Government account calculated on half year basis on 30th September and 31st March every year and remitted before the 15th of the succeeding month.
- 5. Thereafter, in the Government Order 4th read above, the Government have authorised the Deputy Secretary (Budget), Finance Department to execute the agreement as "Guarantor" on behalf of the Government of Tamil Nadu.
- 6. In the letter seventh read above, the Chairman and Managing Director (FAC), Tamil Nadu Water Resources Conservation and Rivers Restoration Corporation Limited, has requested orders for release of the State's share of 10% of the project cost i.e. Rs.93.31 Crore for making necessary payment in full / then and there during execution of the work of Extension, Renovation and Modernization of Lower Bhavani Sub basin in Cauvery basin at an estimated cost of Rs.933.10 crore.
- 7. The Government, after careful examination, have decided to accept the proposal of the Chairman and Managing Director, Tamil Nadu Water Resources Conservation and Rivers Restoration Corporation Limited and accordingly Administrative Sanction is accorded to release of

State's share of 10% of the project cost i.e., Rs.93.31 crore (Rupees Ninety three crore and thirty one lakh only) for the work of Extension, Renovation and Modernisation of Lower Bhavani Sub basin in Cauvery Basin. Further, financial sanction is accorded for a sum of Rs.5,00,00,000/- (Rupees Five crore only) for the year 2021 -2022 and the balance amount will be earmarked for the subsequent financial years based on requirements.

8. The above expenditure sanctioned in para 7 above, shall be debited into the following head of account. (40-01)

4700 - Capital Outlay on Major Irrigation 01 Cauvery Basin - 800 Other expenditure - State's Expenditure - CA - Canals 416 Major works - 01 Major Works.

- 9. The expenditure sanctioned in para 7 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be met by drawal of an advance from the Contingency Fund. The Engineer-In-Chief and Chief Engineer (General), Water Resources Department, Chennai-5, is directed to send necessary proposals to Government in Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules,1963 along with copy of this order for sanction of an advance from the Contingency Fund. Orders regarding which will be issued by Finance (BG-I) Department separately. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in Supplementary Estimate 2021 2022 to Finance (PW-II / BG-I) Department at an appropriate time.
- 10. This order issues with the concurrence of Finance Department vide its U.O. No.1468/PW-II/2022, dated. 03.02.2022 and Additional Sanction Ledger No.1541 (One thousand five hundred and forty one)
