ORDER:

In the Budget session held on 19.06.2017, the Hon'ble Chief Minister has made an announcement on the floor of the Tamil Nadu Legislative Assembly under Rule 110 that a sum of Rs.15.00 crore would be allotted for dismantling of existing structure and construction of New District Sports Complex Building including Gallery for Spectator, District Sports and Youth Welfare Officer room, Administrative room, Coaches room, Players changing room, Rest room and Store room etc., at Kancheepuram.

2. In the letter read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that the Government has created a lot of sports infrastructure facilities in Tamil Nadu. For the Development of Sports in the District, the Sports Development Authority of Tamil Nadu is having District Sports Complex in all Districts except Tiruppur and Vellore. In addition to that, 27 Swimming Pools and 17 Multipurpose Indoor Stadia are also functioning under the control of SDAT. Most of the District Sports Complexes constructed in the District units are more than 15 to 40 years old. The District Sports Complex at Kancheepuram was constructed way back in 1975-1976. Since its inception, the Stadium has been widely utilized for hosting various competitions, training programmes and coaching camps. Due to normal wear and tear, the buildings are now in dilapidated condition.

- 3. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to approve and sanction a sum of Rs.15.00 crore to Construct a new District Sports Complex building comprising of Gallery for spectators, District Sports & Youth Welfare Officer room, Administrative office, Coaches room, players changing room, rest rooms, store room, etc., by dismantling the existing structure in the District Sports Complex at Kancheepuram.
- 4. The Government after careful examination, sanction a sum of Rs.14,66,00,000/- (Rupees Fourteen crore and sixty six lakh only) for dismantling of existing structure and construction of New District Sports Complex Building including Gallery for Spectator, District Sports and Youth Welfare Officer room, Administrative room, Coaches room, Players dress changing room, Rest room and Store room etc., at Kancheepuram subject to the following:
 - i. Provision for Gallery chairs Rs.15 lakh deleted.

ii. Provision for kitchen restricted to Rs.5 lakh.

- iii. Provision for 2 teak doors and entrance door restricted to Rs.5.5 lakh.
- iv. Provision for the track formation restricted to Rs.10 lakh.
- Provision for parking and footpath deleted.
- 5. The amount sanctioned in para 4 above shall be debited under the following head of account:-

"2204-00 Sports and Youth Services – 104 Sports and Games-State's Expenditure - JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex-09 Grants-in-Aid-02 Grants for Creation of Capital Assets" (DPC 2204 00 104 JW 0927)

- 6. Necessary funds will be provided in BE 2018-2019. The Member Secretary, Sports Development Authority of Tamil Nadu is authorized to incur the expenditure sanctioned in para 4 above during the next financial year.
- 7. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Office, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai during 2018-2019. The above sanctioned amount shall not be paid in cash but shall be credited into the following Head of account:-

"K Deposits and Advances (B) Deposits not bearing interest-8443 00 Civil Deposits-800 Other Deposits-CH Deposits of Sports Development Authority (DPC 8443 00 800 CH 000D)" by means of Cheque / Demand Draft drawn in favour of PD Account No.6184513932.
