**ORDER:**

The Deputy Director General, National Cadet Corps has informed that the Republic Day Celebrations and Ceremonial March Past is being held at Marina, Chennai on 26<sup>th</sup> January every year. Approximately 200 National Cadet Corps Cadets, constituting “NCC Contingent” participate in the event. The event is a prestigious event for the State Government as Hon'ble Governor, Hon'ble Chief Minister, Hon'ble Ministers and all dignitaries of the State Government witness the event.

2. He has further informed that there is a separate budget allocation for Republic Day Contingent who takes part in Parade at Rajpath at New Delhi, TSC at New Delhi, VSC at Jodhpur and NSC at Karwar by the State Government with which complete kitting constituting uniform, travelling and messing expenditure are met, there is no budget allocation for Republic Day Contingent which takes part at Republic Day parade of Marina being conducted at Chennai, every year which is a prestigious event for the Tamil Nadu Government and a great matter of pride of National Cadet Corps Cadets in front of home crowd. However, over the years, it has been observed that the pride of National Cadet Corps Cadets is diminishing as they were made to march with old uniform. However, the Deputy Director General, National Cadet Corps has stated that Cadets for Republic Day Celebrations at Marina are selected after screening best Cadets from all over Tamil Nadu, similar to the selection of

Cadets for Republic Day Contingent, New Delhi. Though the above event is a prestigious milestone event; yet the National Cadet Corps Cadets are lacking much behind in worn out National Cadet Corps Uniform, which requires immediate action.

3. The Deputy Director General, National Cadet Corps has informed that the total National Cadet Corps contingent for Republic Day and Ceremonial March past at Marina will be 200 Cadets. The marching contingent with arms will be of 100 cadets consisting of 50 boys and 50 girls cadets. In addition, it has been planned to include, two "NCC Bands" of 100 cadets i.e., one each from Sainik School Coy NCC, Amaravathinagar and another from any Government / Private Institution comprising of 50 NCC Cadets each in the Republic Day Contingent and Ceremonial March past at Marina. Hence, a total number of 200 NCC Cadets will be taking part in the celebration. In this connection, he has informed the Government that the following minimum essential expenditures are proposed for approval and allocation of budget as follows:

The Deputy Director General, National Cadet Corps has requested the Government to accord sanction for a sum of Rs.6,80,000/- (Rupees Six Lakh and Eighty Thousand only) as recurring expenditure towards the amount for improved and smarter participation of "NCC Contingent" in the Republic Day Celebrations and Ceremonial March Past at Marina, Chennai.

5. The Government after careful examination sanction a sum of Rs.6,80,000/- (Rupees Six Lakh and Eighty Thousand only) as recurring expenditure towards the amount for improved and smarter participation of "NCC Contingent" in the Republic Day Celebrations and Ceremonial March Past at Marina, Chennai.

6. The expenditure sanctioned in para 5 above shall be debited under the following head of account:-

"2204-00 Sports and Youth Services - 102 Youth Welfare Programmes for Students - State's Expenditure - AF National Cadet Corps - 72 Training (DPC 2204 00 102 AF 7203)

7. Necessary additional funds of Rs.6,80,000/- will be provided in RE/FMA 2017-18. Pending provision of such funds, the Deputy Director General, National Cadet Corps is authorized to draw and disburse the amount sanctioned in para 5 above. The Deputy Director General, National Cadet Corps is directed to include the expenditure sanctioned above while sending the budget proposal for RE/FMA 2017-18 to Government in Finance (Edn-1) Department without fail.
