ORDER:

The Hon'ble Minister, Youth Welfare and Sports Development has made the following announcement for the year 2018-19 on the floor of the Legislative Assembly,

திருப்பூர் மாவட்டம், உடுமலைப்பேட்டை வட்டம், அமராவதி நகரில் செயல்பட்டுவரும் சைனிக் பள்ளியின் முதன்மை நோக்கமானது, மாணவர்களை முப்படைகளில் சேர்வதற்கு உத்வேகப் படுத்துவதேயாகும். இப்பள்ளியில் பயிலும் 676 மாணவர்களும் தேசிய மாணவர் படையில் சேர்வது கட்டாயமானது. எனவே, அமராவதி நகரிலுள்ள சைனிக் பள்ளியின் தேசிய மாணவர் படையினரின் துப்பாக்கி சுடுதல் பயிற்சிக்காக ரூ. 3.00 இலட்சம் செலவில் .22 துப்பாக்கி சுடுதல் பாவிப்பு கொள்முதல் செய்யப்படும்.

2. In the letter read above, the Deputy Director General, National Cadet Corps has stated that the shooting competition plays a vital role

amongst the various subject / Training imparted to NCC Cadets. Now a days India bags various laurels in the Shooting Competitions at Asian Games, Common Wealth Games and the Olympics. Further, the performance of NCC Cadets at GV Mavlankar Shooting Competition (National Level) is par excellence comparing to other participants.

3. The Deputy Director General, NCC has further stated that the students of Sainik School, Amaravathi Nagar are Junior Division Cadets and given Military way of living while learning. In addition to, their academic and training curriculum, firing training on Firing Simulator would be suitable for the Sainik School Junior Division students which would pave easier way and motivation to join into Armed Forces. After seeing the performance of Indian players at various International Shooting Competition, the demand for undergoing shooting practices is on a steep increase amongst the young budding NCC Cadets.

4. The Deputy Director General, NCC has, therefore, requested the Government to sanction a sum of Rs. 3,00,000/- towards the amount for procurement and installation of .22 Rifle Firing Simulator at Sainik School Coy NCC JD, Amaravathi Nagar as announced in para 1 above.

5. The Government after careful examination, hereby accord sanction for a sum of Rs.3,00,000/- (Rupees Three Lakh only) for procurement and installation of .22 Rile Firing Simulator at Sainik School Coy NCC, JD, Amaravathi Nagar to import firing training on Fixing Simulator.

6. The expenditure sanctioned in para 5 above shall be debited under the following head of account:-

"2204-00 Sports and Youth Services – 102 Youth Welfare Programmes for Students – State's Expenditure – AF National Cadet Corps - 19 Machinery and Equipments – 01 Purchase." (DPC 2204 00 102 AF 1914)

7. Necessary additional funds will be provided in RE/FMA 2018-19. Pending provision of such funds in RE/FMA 2018-2019, the Deputy Director General, National Cadet Corps is authorized to draw and disburse the amount sanctioned in para 5 above after deducting the income tax, if required to do so. The Deputy Director General, National Cadet Corps is also directed to include the expenditure sanctioned above,

while sending the Budget proposal for RE/FMA 2018-19 to Finance (Edn-I) Department without fail.

8. This order issues with the concurrence of Finance Department vide its U.O.No 46904/Edn-I/2018, dated 25.09.2018 and Additional Sanction Ledger No.1368 (One thousand three hundred and sixty eight).


