**ORDER:**

In the letter 1<sup>st</sup> read above, the Deputy Director General, National Cadet Corps has stated that the Director General, National Cadet Corps, New Delhi has informed that with a view to expand National Cadet Corps to rural and backward areas, he has shortlisted Rameswaram to be established as Station for a NCC Naval Unit under Phase IV. This will not only expand the coverage of National Cadet Corps to coastal / rural areas in Tamil Nadu viz., Rameswaram, but it will also serve to give a great opportunity to the students of Ramanathapuram District to enhance their overall job / career prospects by joining the National Cadet Corps.

2. The Deputy Director General, National Cadet Corps was requested to furnish the details of proposed fund allotment in the 12<sup>th</sup> Five Year Plan. Accordingly, he has furnished the details as follows:-

3.The Deputy Director General, National Cadet Corps has stated that the raising of Naval Unit can happen / mostly happens in a hired building / any other Government building pending construction of permanent or permanent accommodation in the land allotted in many cases. In the State of Tamil Nadu, such as 38 National Cadet Corps Group Headquarters / Units, out of 56 units and Group Headquarters / Units are accommodated in a hired buildings even now functioning efficiently. Thus, the new Naval Unit will be one more additional unit starting in a hired building / Government building.

4. In the letter 3<sup>rd</sup> read above, the Deputy Director General, National Cadet Corps has requested to give the State Government's concurrence for raising the Naval Unit in Rameswaram to facilitate sanction by the Ministry of Defence, Government of India / Director General, National Cadet Corps and grant administrative sanction the sum of Rs.61,62,512/- for the establishment

of a Naval Unit at Rameswaram, Ramanathapuram District eventually to obtain the approval of the Government of India.

5. The Government after careful examination, give concurrence and accord administrative sanction for a sum of Rs.61,62,512/- (Rupees Sixty one lakh sixty two thousand five hundred and twelve only) for establishment of NCC Naval Unit at Rameswaram in Ramanathapuram District.

6. This order issues with concurrence of the Finance Department vide its U.O. No. 5106/Edn-1/2019, dated 07.02.2019.


