ORDER:

In the Government order first read above, orders were issued for sanction of High Cash Incentive to the Medal Winners in Olympics, Asian, Commonwealth, South Asian Federation and National Games and their Coaches.

2. In the Government Order second read above, orders were issued for sanction of Cash Award to the winners in the Silent Olympics, Special Olympics, Paralympics and FESPIC games/ International Competitions for hearing impaired, mentally retarded, physically and visually handicapped.

3. In the Government Order third read above, orders were issued for sanction of cash incentives to National and International Competitions in Chess, Carrom, Tennikoit and Powerlifting.

4. In the Government Order fourth read above, orders were issued for upward revision of cash incentives to the medal winners in Olympics, Asian Games, Commonwealth Games, South Asian Federation Games and National Games.

5. In the Government Order fifth read above, amendment was issued to Government Order fourth read above to make team games in National Games eligible for cash incentive.

6. In the Government Order sixth read above, amendment was issued to Government Order fourth read above for sanction of cash incentive to medal winners in National School Games, Asian School Games and World Schools Championship.

7. In the letter seventh read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that regarding other sports disciplines and para sports, the Government have been sanctioning special cash incentive on case to case basis, which resulted delay in disbursement of cash award to the sportspersons in time.

8. The Member Secretary, Sports Development Authority of Tamil Nadu has, therefore, sent a consolidated proposal for sanction of High Cash Incentive to the sportspersons belonging to Tamil Nadu who won medals in International and National Level Competitions and their coaches.

9. The Hon'ble Chief Minister has announced in the Tamil Nadu Legislative Assembly under rule 110 on 09.07.2019 that, the scheme of High cash incentives will be expanded to cover different international championships, national championships and recognized sports competitions for differently abled persons.

10. The Government examined the proposal carefully and decided to accept it. Accordingly in supersession of the Government Orders 1 to 6 read above, the Government accord sanction of High Cash Incentive to the sportspersons belonging to Tamil Nadu who won medals in International and National Level Competitions and their coaches as detailed in the Annexure

with effect from the date of issue of this order. The terms and conditions mentioned below shall apply for sanction of High Cash Incentive.

- i. Competitions mentioned in Parts-1, 2, 3A, 3B and 4 of the Annexure to this Government Order alone will be eligible for the High Cash Incentive.
- ii. Any addition or deletion of disciplines in Part 3A and 3B of Annexure shall be recommended to Government by a committee comprising of Principal Secretary, Youth Welfare and Sports Development Department, Secretary (Expenditure) Finance Department and the Member Secretary, Sports Development Authority of Tamil Nadu.
- iii. In case of national championships, national games and other national level competitions only those sportspersons representing Tamil Nadu shall be eligible for high cash incentive. In case of team games at National Championships, National Games and other eligible National Level Competitions the entire team would be from Tamil Nadu and the following system will be followed for determining high cash incentives:-
 - The amount of cash incentive in respect of team events for Sports disciplines in national championships and national games and other National Level Competitions will be determined as under:-

Strength of 'Team' : Number of times, the cash incentive on the ground sanctioned for medal winners in national championships and national games

- The actual cash incentive determined as above will be shared equally among the team members. However, no member of team will get less than 50% of the cash incentive amount being sanctioned for medal winners in national championships and national games.
- Cash incentive for coach / coaches will be 15% of total amount given to team.

iv. Cash Incentive to Coaches:

15% of the High Cash Incentive given to medal winner will be awarded to the coaches, subject to the condition that sportspersons should have undergone coaching under the said Coach atleast for a minimum period of 3 years. An Undertaking from the sportsperson with endorsement from the Sports Association concerned have to be obtained. Coach can be engaged from anywhere in India. Cash incentive will not be sanctioned to the coaches of the medal winners in School Games and University Games.

v. Eligibility:

- a. The sportsperson shall be a resident of Tamil Nadu atleast for a period of five years before the date of medal winning performance. Nativity Certificate from the Competent authority shall be produced; Students who had undergone for foreign studies and sportspersons who had undergone for foreign training are exempted from this condition of 5 years of residence in Tamil Nadu.
 - b. The sportsperson must have participated in the National Championship and National Games on behalf of Tamil Nadu within the last four years before the date in which he won the medal, if he has participated in that National Championship or National Games.
 - c. High Cash Incentive is not applicable for Invitation / Open / Memorial competitions.
- vi. The International sports competitions should have been conducted by the international sports body recognized by International Olympic Committee.
 - vii. The National sports competitions should have been conducted by the National Sports Federations recognized by Indian Olympic Association, Paralympic Committee of India, All India Sports Council of the Deaf, Special Olympics Bharat, Indian Blind Sports Association.
 - viii. Regarding Senior National Championships, conducted by a recognized body, only one championship for each discipline, which is considered to be the best among all in a year, will alone be considered for award of High Cash Incentive.

11. The sanction of expenditure in this regard will be accorded based on requirement of appropriate funds.

12. The sanction of expenditure shall be debited under the following head of account:-
