ORDER:

In the G.O. 1st read above, orders have issued according Administrative Sanction for a sum of Rs.92.13 crore for hosting of 44th International Chess Olympiad by the Government of Tamil Nadu.

2. In the reference 2nd read above, the Hon'ble Chief Minister has made an announcement in the floor of the Legislative Assembly on 21.04.2022 under rule 110 as follows:

"இந்தியாவில் விளையாட்டு உலகின் மணிமகுடமாக விளங்கக்கூடிய 44-வது உலக செஸ் ஒலிம்பியாட் போட்டிகள் வரும் 28.07.2022 முதல் 10.08.2022 வரை தமிழ்நாட்டில் உலகமே வியக்கக்கூடிய வகையில் பிரம்மாண்டமாகத் தமிழ்நாடு அரசால் நடத்தப்பட உள்ளது. 44-வது உலக செஸ் ஒலிம்பியாட் போட்டிகளில் உலகில் உள்ள 180 நாடுகளைச் சார்ந்த சதுரங்க விளையாட்டு வீரர்கள் அதிலே பங்கு பெறவிருக்கிறார்கள். 44-வது உலக செஸ் ஒலிம்பியாட் போட்டிகளை நடத்துவதற்கு இன்றே ஒரு குழு ஏற்படுத்தப்பட்டு, அந்தப் பணிகளும் சிறப்பாகச் செயல்பட வழிவகை செய்யப்பட்டுள்ளது. இதன்மூலமாக விளையாட்டுத் துறையில் தமிழகம் முன்னணி மாநிலமாக வளர்ந்து சிறக்க வழிவகை செய்யப்பட்டுள்ளது"
