#### ORDER:

In the Government Order 1<sup>st</sup> read above, orders were issued for sanction of High Cash Incentive to the Sportspersons belonging to the Tamil Nadu who won medals in the International and National Level Sports Competition and their Coaches. Among other things, the High Cash Incentive for SAF Championship / Senior National Championship (held annually) SI.No.16 in part 1 is as follows:

- 2. In the reference second read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that Tamil Nadu Men Hockey Team had secured Silver medal in the 12<sup>th</sup> Senior National Championship held at Bhopal, Madhya Pradesh from 6<sup>th</sup> to 17<sup>th</sup> April 2022 and requested to sanction high cash incentive for their medal winning achievement.
- 3. He has also stated that, the General Secretary, Tamil Nadu Hockey Association, Chennai has informed that the Tamil Nadu Men Hockey Team has secured Silver medal in the 12<sup>th</sup> Senior National Championship held at Bhopal, Madhya Pradesh from 6<sup>th</sup> to 17<sup>th</sup> April 2022. Further, it has been noted that all the sportspersons are belonging to Tamil Nadu and have been residents of the State of Tamil Nadu.

4. As per the G.O. first read above, the Tamil Nadu Men Hockey Team who had secured Silver medal in the 12<sup>th</sup> Senior National Championship held at Bhopal, Madhya Pradesh from 6<sup>th</sup> to 17<sup>th</sup> April 2022 are eligible for the high cash incentive as stated below:

- i. A team of more than 10 persons is 5 times = Rs.3.00 x 5 times = Rs.15.00 Lakh.
- ii. As per G.O. minimum 50% of high cash incentive should be given to medal winners. 50% of the cash incentive amount is Rs.1.50 Lakh x 18 Nos. = Rs.27.00 Lakh
- 5. The Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to sanction a sum of Rs.27.00 Lakh (Rupees Twenty Seven Lakh Only) to the above said 18 sportspersons of Tamil Nadu Men Hockey Team who had secured Silver medal in the 12<sup>th</sup> Senior National Championship held at Bhopal, Madhya Pradesh from 6<sup>th</sup> to 17<sup>th</sup> April 2022.
- 6. The Government, after careful consideration, have decided to accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accordingly sanction a sum of Rs.27.00 Lakh (Rupees Twenty Seven Lakh Only) to the above said 18 sportspersons of Tamil Nadu Men Hockey Team who had secured Silver medal in the 12<sup>th</sup> Senior National Championship held at Bhopal, Madhya Pradesh from 6<sup>th</sup> to 17<sup>th</sup> April 2022 subject to the condition that the eligibility criteria stipulated in G.O.(Ms).No.18, Youth Welfare and Sports Development (S1) Department, dated 27.09.2019 are fulfilled by the medal winners.

7. The expenditure sanctioned in para 6 above shall be debited under the following head of account:-

"2204-00 Sports and Youth Services – 104 Sports and Games – State's Expenditure – AR Grants to Sports Development Authority of Tamil Nadu for Financial Assistance to Sports persons – 309 Grants-in-Aid-01 Grants for Current Expenditure".

- 8. Necessary additional funds of Rs.27,00,000/- will be provided in RE/FMA 2022-23. Pending provision of such funds, the Member Secretary, Sports Development Authority of Tamil Nadu is authorized to draw and disburse the amount sanctioned in para 6 above. This expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates. 2022-23. The Member Secretary, Sports Development Authority of Tamil Nadu is directed to include the expenditure sanctioned above, while sending the Budget proposal for RE/FMA 2022-23 and also to send necessary Explanatory Notes for including the above expenditure in the Supplementary Estimates 2022-23 to Finance (BG-I)/(Edn-I) Department without fail.
- 9. The amount sanctioned in para-6 above shall not be paid in cash but shall be credited into the following Head of account:-

The Member Secretary, Sports Development Authority of Tamil Nadu is directed to prepare an adjustment bill for effecting the above transfer and present it to the Pay and Accounts Office, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Chennai during the year 2022-23.
