ORDER:

In the Government Order first read above, orders have been issued for sanction of High Cash Incentive to the sportspersons belonging to Tamil Nadu who won medals in International and National Level Competitions with effect from the date of issue of the order. Among other things, the High Cash Incentive for the School Games and University Games organized by All India Inter University (held annually) in Sl.No.2 in part 2 of the above said G.O is as follows:

The Member Secretary, Sports Development Authority of Tamil Nadu in his letter third read above, has stated that in the All India University Games for the year 2019-2020 held in various places in the Country, Tamil Nadu contingent has participated in various disciplines and 53 Boys had won total 22 medals and 91 Girls had won a total of 27 medals. 3. Further, the Member Secretary, Sports Development Authority of Tamil Nadu has also furnished the names of the students, Merit Certificate, Residential Certificate, medals won and the eligible amount of High Cash Incentive of the medal winners.

4. The Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to sanction a sum of Rs.2,13,50,000/- (Rupees Two crore thirteen lakh and fifty thousand only) to 144 medal winners in All India Inter University Games for the year 2019-2020.

5. The Government, after careful examination, have decided to accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accordingly sanction a sum of Rs.2,13,50,000/- (Rupees Two crore thirteen lakh and fifty thousand only) to 144 medal winners in All India Inter University Games for the year 2019-2020, subject to the condition that the eligibility criteria stipulated in G.O.(Ms).No.18, Youth Welfare and Sports Development (S1) Department, dated 27.09.2019 are fulfilled by the medal winners.

6. The expenditure sanctioned in para-5 above shall be debited to the following head of account:-

"2204-00 Sports and Youth Services – 104 Sports and Games – State's Expenditure – AR Grants to Sports Development Authority of Tamil Nadu for Financial Assistance to Sportspersons – 309 Grants-in-Aid-01 Grants for Current Expenditure".

7. Necessary additional funds of Rs.2,13,50,000/- will be provided in RE/FMA 2022-23. Pending Provision of such funds, the Member Secretary, Sports Development Authority of Tamil Nadu is authorized to draw and disburse the amount sanctioned in para –5 above. This expenditure shall be brought to the notice of the legislature by specific inclusion in the supplementary estimates 2022-2023. The Member Secretary, Sports Development Authority of Tamil Nadu is directed to include the expenditure sanctioned above, while sending the budget proposal for RE/FMA 2022-23 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2022-2023 to Finance (Edu-I/BG-I) Department without fail.

8. The amount sanctioned in para-5 shall not be paid in cash but shall be credited into the following Head of account:-

"K Deposits and Advances (B) Deposits not bearing interest - 8443 00 Civil Deposits – 800 Other Deposits – CH Deposits of Sports Development Authority of Tamil Nadu – 801 Receipts – 02 Not Bearing interest – 802 Outgo – 02 Not bearing Interest"

The Member Secretary, Sports Development Authority of Tamil Nadu is directed to prepare an adjustment bill for effecting the above transfer and present it to the Pay and Accounts Office, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Chennai during the year 2022-23.
