### **ORDER:**

The Deputy Director General, National Cadet Corps Directorate has requested the Government to issue necessary order for filling up of vacancies in the post of Driver in National Cadet Corps Gp HQS and Units situated at Coimbatore City and its suburbs on regular basis in the time scale of pay of Rs.5200-20200+GP 2400/- in PB1 through Employment Exchange on par with the order already issued by the Government in regard to the filling up of vacancies in the post of Driver at Chennai and its suburbs.

2. In the Government letter 6<sup>th</sup> read above, Government have requested the Deputy Director General, National Cadet Corps to confirm whether the above said 9 posts of Driver are vacant for more than 3 years. If so, necessary revival proposal shall be sent to Government.

3. In the letter 7<sup>th</sup> read above, the Deputy Director General, National Cadet Corps has stated that out of 9 sanctioned posts of Driver referred to NCC Directorate letter dated 10.12.2015, a total number of 8 posts sanctioned to the NCC units

situated at Coimbatore are lying vacant for more than three years. The details of the same are given below:-

4. Further he has stated that one post of Driver sanctioned to 5 (TN) Girls Bn NCC, Coimbatore, is lying vacant with effect from 30.04.2014, which is within the period of three years. Subsequent to the proposal taken up by the National Cadet Corps Directorate for appointment of regular drivers in place of TEXCO drivers, Thiru A Subramanian, Driver of NCC Group Headquarters, Coimbatore, died while in service on 28.07.2015. Filling up of the above vacancies in the post of Drivers numbering 10 existing as on date at NCC Gp HQs, Coimbatore and units situated at Coimbatore and also the future vacancies on regular basis is just and also essential in view of the recurring training and administrative commitments of the Department.

5. The Deputy Director General, National Cadet Corps has requested the Government for revival of the following permanent sanctioned post of Driver to the NCC offices situated at Coimbatore:-
