ORDER:

In the Government order first read above, the Government have sanctioned additional expenditure of a sum of Rs.55,934/- (Rupees fifty five thousand nine hundred and thirty four only) towards enhancement of rate of daily allowance of Rs.100/- to Associate National Cadet Corps Officers (ANOs) and National Cadet Corps Cadets during various camps and Training courses conducted by National Cadet Corps Department with effect from the academic year 2013-14. The amount has been sanctioned to be incurred from the Sub Head "54 Expenses on Conducted Tours," i.e., for the ANOs and Cadets who are detailed to attend camps.

- 2. In the Government order second read above, Government have sanctioned a sum of Rs.2,35,000/- (Rupees Two lakhs thirty five thousand only) towards enhancement of rate of daily allowance from Rs.35/- and Rs.30/- to Rs.100/- to Associate National Cadet Corps Officers (ANOs) and National Cadet Corps Cadets respectively during various Camps and Training courses (Pre-Commission course, Refresher Training course, Attachment with Military Academy, etc.).
- 3. The Deputy Director General, National Cadet Corps has stated that the Government have accorded sanction to incur a sum of Rs.55,934/- (Rupees fifty five thousand nine hundred and thirty four only) under the sub head of account

- "54 Expenses and Conducted Tours" (Camps) and a sum of Rs.2,35,000/-(Rupees two lakhs and thirty five thousand only) to be incurred under the head of account "72 Training" (Courses) with effect from the year 2013-14.
- 4. Further he has stated that the Government of India, Ministry of Defence, vide its letter dated 24.07.2015 have conveyed the sanction of the competent authority for revision in the rates of payment of Daily Allowance for journey performed in connection with camps and courses by Associate NCC Officers and NCC Cadets at the rates mentioned below:-

- 5. Further he has stated that Government of India have stated that the expenditure involved in journey performed in connection with Camps shall be shared between Central and State Governments in the ratio of 75:25 respectively. The Government of Tamil Nadu have partly implemented the enhanced rates of daily allowance from Rs.35/- to Rs.100/- in respect of Associate NCC Officers and from Rs.30/- to Rs.100/- in respect of NCC Cadets who attend Camps and Courses respectively.
- 6. The Deputy Director General, National Cadet Corps has requested the Government to sanction an additional amount of Rs.1,31,618/- (Rupees one lakh thirty one thousand six hundred and eighteen only) per annum towards revision of rates of Daily Allowance from Rs.35/- to Rs.130/- in respect of ANOs and from Rs.30/- to Rs.125/- in respect of NCC Cadets who attend various camps and Training courses (Pre-Commission Course, Refresher Training Course, Attachment with Military Academy etc).
- 7. The Deputy Director General, National Cadet Corps has furnished the details of financial implications of the proposal for revision of rates for Daily Allowance expenses as detailed in Annexure I and II.
- 8. The Government have already enhanced the rate of daily allowance from Rs.35/- to Rs.100/- to Associate NCC Officers (ANOs) and from Rs.30/- to Rs.100/- to National Cadet Corps Cadets respectively who attend various Camps and Training Courses (Pre-commission course, Refresher Training course, Attachment with Military Academy etc.,

9. Now the Deputy Director General, National Cadet Corps has requested to revise the Daily Allowance from Rs.100/- to Rs.130/- for ANOs and from Rs.100/- to Rs.125/- for National Cadet Corps Cadets respectively who attend various National Cadet Corps Camps and training courses and has requested for an additional sanction of Rs.1,31,618/- (Rupees one lakh thirty one thousand six hundred and eighteen only) based on the enhancement of daily allowance. The additional expenditure to the State Exchequer from the year 2015-16 will be as under:

The Government after careful examination sanction a sum of Rs.1,31,618/- (Rupees one lakh thirty one thousand six hundred and eighteen only) as recurring expenditure per annum towards enhancement of rate of daily allowance from Rs.100/- to Rs.130/- to Associate NCC Officers and from Rs.100/- to Rs.125/- to National Cadet Corps Cadets respectively who attend various Camps and Training courses (Pre –Commission course, Refresher Training course, Attachment with Military Academy, etc.) prospectively with effect from 01.04.2016.
- 11. The expenditure sanctioned in para 10 above shall be debited under the following head of account:-
