# **ORDER:**

The Member Secretary, Sports Development Authority of Tamil Nadu in his letter second read above has stated that the following sportspersons have won medals at the 17<sup>th</sup> Asian Games held at Incheon, South Korea from 19<sup>th</sup> September to 4<sup>th</sup> October 2014. The eligible High Cash Incentive as per Government Order first read above is as follows:

2. As per the Government Order first read above, one of the conditions is that for sanction of Cash Incentives, the medal winners should be the resident of Tamil Nadu for the last 5 years, prior to winning the medals.

3. The Member Secretary, Sports Development Authority of Tamil Nadu has stated that out of the above said 14 medal winners, Thiru. Rupinder Pal Singh from Faridkot in Punjab has joined Indian Overseas Bank, Chennai during April 2010 and has been representing Tamil Nadu State Hockey Team in the various National Tournaments. He is a resident of Tamil Nadu for 4 years and 6 months only. Thus he has not fulfilled the condition stipulated in para 6 (iii) of the Government Order first read above. The Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to sanction the High Cash Incentive of Rs.50.00 lakhs to Thiru. Rupinder Pal Singh as a special case.

4. The Government after careful consideration, sanction the High Cash Incentive of Rs.50,00,000/- (Rupees fifty laksh only) to Thiru Rupinder Pal Singh for securing Gold medal at Hockey at the 17<sup>th</sup> Asian Games held at Incheon, South Korea from 19<sup>th</sup> September to 4<sup>th</sup> October 2014, as a special case, in relaxation of para 6 (iii) of Government Order first read above.

5. The amount sanctioned in para 4 above shall be debited under the following Head of account:

"2204 - 00. Sports and Youth Services-104. Sports and Games-I. Non-Plan-AR. Grants to Sports Development Authority of Tamil Nadu for Financial assistance to Sportsmen-09. Grants-in-aid-01. Grants for Current Expenditure" (DPC 2204 00 104 AR 0917).

6. Necessary funds will be provided in FMA 2014-15. However, this expenditure shall be brought to the notice of the Legislature, by specific inclusion in the Supplementary Estimates 2014-2015. Pending provision of additional funds, the Member Secretary, Sports Development Authority of Tamil Nadu is authorized to draw and disburse the amount. The Member Secretary, Sports Development Authority of Tamil Nadu is requested to include the same in the proposal for

FMA 2014-2015. He shall also submit necessary explanatory note to the Government in Finance (BG-I/Edn-I) Department at appropriate time, without fail.

7. The Member Secretary, Sports Development Authority of Tamil Nadu is authorized to present the bill to the Pay and Accounts Officer, Secretariat, Chennai-9, through Under Secretary to Government, Youth Welfare and Sports Development Department, Secretariat, Chennai-9. The above sanctioned amount shall not be paid in cash but shall be credited to the following Head of account:-

"K.Deposits and Advances (B). Deposits not bearing interest -8443.00 Civil Deposits-800. Other Deposits-CH. Deposits of Tamil Nadu Sports Development Authority (DPC 8443.00.800.CH.000D) By means of Cheque / Demand Draft drawn in favour of PD Account No.6184513932.
