### ORDER:

In the Tamil Nadu Legislative Assembly under Rule 110, the Hon'ble Chief Minister has announced that the Government have decided to establish a sports hostel in the remaining 23 districts in a phased manner.

2. Based on the above announcement, in Government Order first read above, the Government have accorded administrative sanction for the establishment of Sports Hostels in 23 Districts with an intake capacity of 60 students in each and to cover 5 Districts viz., Coimbatore, Thanjavur, Cuddalore, Dindigul and Nagercoil in first phase during the year 2011-2012.

3. Subsequently in Government Order 2<sup>nd</sup> read above, the Government have sanctioned a non-recurring grant of Rs.393.30 lakhs and recurring grant of Rs.504.18 lakhs for establishment of Six Sports Hostels in Namakkal, Ariyalur, Thoothukudi, Perambalur, Sivaganga and Theni in 2<sup>nd</sup> phase during the year 2012-2013.



4. In the letter 3<sup>rd</sup> read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that, now it is proposed to establish 5 more new sports hostels in the following 5 districts which would start functioning from the academic year 2015-2016 with an intake strength of 60 under Phase-III.

1. Ramanathapuram
2. Pudukottai
3. Dharmapuri
4. The Nilgiris
5. Villupuram

The details of expenditure required to manage the proposed 5 new Sports Hostels efficiently are as follows:-

The total recurring grant for 5 Hostels will be Rs.2,89,60,000/- and non-recurring grant will be Rs.3,25,25,000/-

5. The Member Secretary, Sports Development Authority of Tamil Nadu has further stated that the amount required as Recurring Expenditure is Rs.2.90 Crores and as Non-Recurring expenditure is Rs.3.26 Crores. Total amount required for 2015-2016 for establishing 5 Sports Hostels would be Rs.6.16 Crores.

6. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction the recurring grant of Rs.2.90 Crores and non-recurring grant of Rs.3.26 Crores immediately to start the sports hostels in the year 2015-16.

7. The Government, after careful consideration, accord sanction for establishment of Sports hostels in 5 Districts viz. Ramanathapuram, Pudukottai, Dharmapuri, The Nilgiris and Villupuram for the year 2015-16 in 3<sup>rd</sup> phase.

8. The Government also sanction a non-recurring grant of Rs.3.26 Crores (Rupees three crores and twenty six lakhs only) and recurring grant of Rs.2.90 Crores (Rupees two crores ninety lakhs only) for establishment of the above Sports hostels.

9. The amount sanctioned in para 8 above shall be debited to the following Heads of Account.
