National Cadet Corps – Enhancement of Petrol, Oil and Lubricants (POL) rates in respect of National Cadet Corps Training Camps conducted in other States and in the State of Tamil Nadu – Sanction- Orders – Issued.

#### ORDER:

In the Government Order first read above, orders were issued for the enhanced Petrol, Oil and Lubricants rates from Rs.35/- to Rs.55/- for Annual Training Camp conducted in Tamil Nadu and from Rs.55/- to Rs.80/- for 6% quantum of petrol diesel for centrally organized camps including National Integration Camps on par with the rate prescribed by Government of India.

- 2. In the letter second read above, the Deputy Director General, National Cadet Corps has requested the Government to accord Concurrence of the enhanced Petrol, Oil and Lubricants rate on par with rate prescribed by Government of India, Ministry of Defence, New Delhi for CATC/ATC from Rs.55/to Rs.125/- + 6% lub chgs and for COC/NIC's from Rs.80/- to Rs.175/- + 6% lub chgs.
- 3. In the G.O.(Ms) No.17, Youth Welfare and Sports Development (YW1) Department, dated 27.01.2014, Government have given its consent towards revision of Petrol, Oil and Lubricant charges with prospective effect at an

additional expenditure to the State to the tune of Rs.9.43 lakhs per annum as per details below:

- 4. In the letter fifth read above, the Deputy Director General, National Cadet Corps has stated that while ordering the above enhancement of petrol rates, Government instructed that the rates will be sanctioned only when the Government of India orders are received to bear 75% of the expenditure and requested the National Cadet Corps Directorate to obtain and communicate the orders of Government of India for revision of Petrol rates and lubricant charges to the Associate National Cadet Corps Officers and Cadets who are attending Centrally Organized Camps and National Integration Camps conducted in other States and in Tamil Nadu.
- 5. The Under Secretary, Ministry of Defence, Government of India, New Delhi in his letter dated 24.07.2015, has conveyed the sanction of the competent authority for revision in the rate of Petrol, Oil and Lubricants admissible during camps as detailed below:

- 6. Further the Deputy Director General, National Cadet Corps has stated that Government of India had revised the rates of Petrol, Oil and Lubricants in terms of litre instead of cost of petrol.
- 7. The Deputy Director General, National Cadet Corps has requested the Government to sanction to the National Cadet Corps Directorate, Chennai to implement the revised rates in terms of 2 Ltrs + admissible lubricant per Associate National Cadet Corps Officer / Cadet for Annual Training Camps and 3 Ltrs + admissible lubricant for Centrally Organized Camps per Associate National Cadet Corps Officer /Cadet as per the Petrol, Oil and Lubricant (POL) rates existing from time to time. As per the prevailing rates of POL as on date, the additional

expenditure works out to Rs.18,25,998/- (Rupees eighteen lakhs twenty five thousand nine hundred and ninety eight only) during the current financial year 2015-16. The details of additional expenditure are detailed in Annexure -I.

- 8. He has also requested to sanction an additional expenditure of Rs.18,25,998/- (Rupees eighteen lakhs twenty five thousand nine hundred and ninety eight only) in the Revised Estimate 2015-16 towards enhancement of Petrol, Oil and Lubricant (POL) rates in respect of National Cadet Corps Training Camps conducted in other States and in the State of Tamil Nadu.
- 9. The Government after careful examination have decided to sanction an additional amount of Rs.10,60,081/- (Rupees ten lakhs sixty thousand and eighty one only) towards enhancement of Petrol, Oil and Lubricant (POL) rates in respect of National Cadet Corps Training camps conducted in other states and in the state of Tamil Nadu with effect from 01.04.2016. (i.e. to implement the revised rates in terms of 2 litres + admissible lubricant per Associate National Cadet Corps Officer/Cadet for Annual Training Camps and 3 litres + admissible lubricants for Centrally Organized Camps per Associate National Cadet Corps Officer / Cadet as per the petrol rates existing from time to time). The details of additional expenditure is detailed in Annexure –II.
- 10. The expenditure sanctioned in para 9 above shall be debited under the following head of account:-

2204-00 Sports and Youth Services – 102 Youth Welfare Programmes for Students –I.Non Plan – AF National Cadet Corps – 54 Expenses on Conducted Tours" (DPC 2204 00 102 AF 5401).

11. The expenditure sanctioned in para 9 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2016-17. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Deputy Director General, National Cadet Corps is directed to calculate the actual amount required for the period upto next supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I/Edn-I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Deputy Director General, National Cadet Corps shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2016-2017, without fail.

12. This order issues with the concurrence of Finance Department vide its U.O.No.15613/Edn-1/2016 dated 02.03.2016 and Additional sanction ledger No.2505 (Two thousand five hundred and five).
