**ORDER:**

In the Government Order first read above, Government have sanctioned a sum of Rs.20.00 lakhs as non- recurring expenditure under the Part II scheme 2013-14 towards purchase of 10 numbers of Precision Rifle for imparting training to National Cadet Corps Cadets.

2. Due to certain administrative reasons, the fund sanctioned by the Government vide G.O.(Ms)No.55, Youth Welfare and Sports Development (YW) Department, dated 26.06.2013 was not utilized by the Deputy Director General, National Cadet Corps in the Financial year 2013-14.

3. The Deputy Director General, National Cadet Corps has stated that at present .22 rifles manufactured by M/s. Indian Ordnance Factory, Rifle factories, Ishapore (WB) are being utilized for imparting training to National Cadet Corps Cadets. These rifles are for general shooting training to be imparted to National Cadet Corps Cadets. At present there is no deficiency of .22 rifles. However, International Shooting Sports Federation (ISSF) Standard .22 Calibre sports rifles are required for National Cadet Corps Cadets to take part in GV Mavlinkar National Rifle Shooting Competitions and National game competitions. These precision shooting rifles are not being manufactured by M/s Indian Ordnance Factories. Rifle Factory, Ishapore. The ibid model is not being manufactured by M/s. Indian Ordnance Factories, Rifle Factory, Ishapore (WB). Further in the



Government letter 3<sup>rd</sup> read above, the Government have clarified that there is no hindrance to process and finalize single tender received through open tender as per Tamil Nadu Transparency in Tenders Act / Rules, provided all other conditions are satisfied. Further, Tamil Nadu Transparency in Tenders Act does not bar in processing single bidder provided both the tender notification and the qualification criteria of the bidder are in order.

4. Further the Deputy Director General, National Cadet Corps has informed that the National Cadet Corps Directorate will purchase 07 (5+2) Nos of .22 Calibre Sports Rifle with accessories from M/s. Syndicate Innovations International Limited, Ghaziabad (UP) during the current financial year 2015-16 and has also requested the Government to revalidate the G.O.(Ms) No.55, Youth Welfare and Sports Development (YW1) Department, dated 26.06.2013 and to sanction Rs.17,95,000/- towards purchase of 07 (5+2) Nos of .22 Calibre Sports Rifle with accessories from M/s. Syndicate Innovations International Limited, Ghaziabad (UP).

5. The Government after careful consideration authorize the Deputy Director General, National Cadet Corps to incur an expenditure of Rs.17,95,000/- (Rupees seventeen lakhs and ninety five thousand only) towards purchase of 7 (5+2) numbers of Precision Rifle for imparting training to National Cadet Corps Cadets from M/s. Syndicate Innovations International Limited, Registered Office at New Delhi-92, Marketing office at Ghaziabad, Uttar Pradesh.

6. The expenditure authorized in para 5 above shall be debited under the following head of account:-

“2204-00 Sports and Youth Services – 102 - Youth Welfare Programmes for Students – I.Non – Plan – AF National Cadet Corps – 44 Arms and Ammunitions – 01 – purchase”  
(DPC 2204 00 102 AF 4411)

7. Necessary funds will be provided in FMA 2015-16 pending provision of such funds in RE/FMA 2015-16. However, this expenditure shall be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2015-2016. The Deputy Director General, National Cadet Corps, Chennai-9 is authorized to incur the expenditure sanctioned in para 5 above. The Deputy Director General, National Cadet Corps is directed to include the expenditure sanctioned in para 5 above, while sending the Budget proposal for FMA 2015-16 and draft explanatory notes for Supplementary Estimates 2015-2016 to Finance (Edn-I) Department without fail.

8. The Deputy Director General, National Cadet Corps shall send the detailed expenditure report, utilization certificate etc., to the Government at the appropriate time.



9. This order issues with the concurrence of Finance Department vide its U.O.No.2275/Edn-I/2016 dated 18.01.2016 and Additional Sanction Ledger No.1968 (one thousand nine hundred and sixty eight).
