ORDER:

In the letter third read above, the Principal Secretary /Member Secretary, Sports Development Authority of Tamil Nadu has informed that in order to enable the coaches to deliver their work in a result oriented manner, the Government have launched " Day Boarders Scheme" in 5 Districts (10 Centres) from the year 2011-12, and sanctioned Rs.18.00 lakhs as recurring grant in the Government Order first read above, for implementation of the said scheme.

2. Further, in order to provide systematic coaching to the identified talents from the suburban area of the district, the Government have also sanctioned Rs.51.32 lakhs as recurring grant for conducting "Week End Coaching Camps" in 4 Districts (as in 5 Centres in each District) as continuous procedure for 8 months in a year from the financial year 2011-12 at an expenditure of Rs.15.80 lakhs per District per annum vide Government Order second read above and Rs.63.20 lakhs afterwards.

3. Both the above said schemes were formulated before extending Sports Hostel facilities in most of the Districts. Nowadays, the Sports Hostels are functioning in all the districts except in few districts which themselves fulfilled the objective of the above said schemes.

4. In the Sports Development Authority of Tamil Nadu – Officers review meeting held on 01.03.2016 and in the Head Office Officers meeting held on

16.03.2016 under the Chairmanship of Principal Secretary / Member Secretary, it was opined that implementation of multiple schemes results in duplication of efforts and therefore in view of the above, it has been suggested to merge the Day Boarders Scheme and Week End Coaching Camp Scheme and revitalize into one new Scheme in the name of "Talent Hunting Camp".

5. Main objective of this scheme is to provide systematic coaching through Sports Development Authority of Tamil Nadu coaches in all District Sports Complexes for 10 boys and 10 girls, for students and non-students under 14 age group in a popular sports discipline of the respective district, for 6 months in continuous process, i.e. 25 days in a month (except sundays – evening session only) by providing conveyance allowance, nutritious diet, sports kit, uniform etc., and the students hunting out of this scheme will be admitted into specialized academies and Sports Hostels of Sports Development Authority of Tamil Nadu.

6. He has added that for the implementation of the new scheme, the budget allotment for both the Schemes mentioned below may be combined and utilized as follows:

7. In this manner, there is no additional funds required to meet out this endeavour.

8. The Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to issue necessary orders to formulate the new scheme in the name of "Talent Hunting Camp" by merging the Day Boarders Scheme and Week End Coaching Camp Scheme and to sanction the budget merely by mingling the funds already allotted for the Day Boarders Scheme and Week End Coaching Camp Scheme (no additional funds required) for the effective implementation of erstwhile Scheme.

9. The Government after careful consideration accord sanction for formulating the new Scheme "Talent Hunting Camp" by merging the Day Boarders Scheme and Week End Coaching Camp Scheme and to sanction the budget merely by mingling the funds already allotted for the Day Boarders Scheme and Week End Coaching Camp Scheme (no additional funds required) as detailed in para 6 above subject to ensuring the enrollment of suburban students and non-students of 14 age group for training in a continuous process of 25 days / month.

10. The expenditure in this regard shall be debited under the following head of account:-

"2204-00 Sports and Youth Services – 104 Sports and Games-Schemes in the Twelfth Five Year Plan – II. State Plan – KQ. Grants to Sports Development Authority of Tamil Nadu for Conducting Sports Coaching and Training Camps -09 Grants – in – aid – 03 Grants for Specific Schemes. (DPC 2204 00 104 KQ 0937)

11. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai. The sanctioned amount shall not be paid in cash but shall be credited into the following head of account by means of Cheque / Demand Draft drawn in favour of PD Account No.6184513932.
