National Cadet Corps – Enhancement of Annual Training Grant from Rs.2,000/-p.a. to Rs.6,000/-p.a. in respect of each NCC Company (including Indep Coy) and from Rs.1,000/-p.a. to Rs.3,000/-p.a. in respect of each NCC Troop in Tamil Nadu – A sum of Rs.9,04,000/- as additional expenditure sanctioned – Orders – Issued.

ORDER:

In the Government order first read above, orders have been issued for the revision in the rates of Annual Training grant to National Cadet Corps Coys/Troops as detailed below:-

- (i) Senior Division/Wing Rs.400/- per coy
- (ii) Junior Division/Wing Rs.200/- per troop
- 2. In the Government order second read above, the Government have accepted the proposal of revision in Annual Training grant amounts to Rs.2,400/-per coy and Rs.1,200/- per troop constituting 40% of State Share. While approving the proposal, Government have also instructed the Deputy Director General, National Cadet Corps to obtain and communicate the orders of Government of India for revision of Annual Training Grant i.e., from Rs.400/- to Rs.2400/- in respect of Senior Division / Wing Coys and from Rs.200/- to Rs.1200/- in respect of Junior Division / Wing Troops.

3. The Deputy Director General, National Cadet Corps has stated that the Government of India, Ministry of Defence vide its letter dated 24.07.2015 had conveyed the sanction of the competent authority for revision in the rate of Annual Training Grant as follows:

The Deputy Director General, National Cadet Corps has requested to sanction an additional amount of Rs.9,20,000/- (Rupees nine lakhs twenty thousand only) (i.e. enhance the Annual Training Grant from Rs.2,000/- per annum to Rs.6,000/- per annum in respect of each NCC Company including indep coy and from Rs.1,000/- per annum to Rs.3,000/- per annum in respect of each NCC Troop) towards enhancement of rates of Annual Training Grant during the current financial year.

6. Further the Deputy Director General, National Cadet Corps has stated that though the extra expenditure works out to Rs.9,20,000/- the additional funds required on this nature would be of Rs.9,04,000/- and its details are furnished below:

- 7. The Government after careful examination direct that the Annual Training Grant of Rs.2,000/- per annum be enhanced to Rs.6,000/- per annum in respect of each NCC company (including indep coy) and that of NCC Troop be enhanced from Rs.1,000/- per annum to Rs.3,000/- per annum with total additional financial implication of Rs.9,20,000/- (Rupees nine lakh and twenty thousand only) per annum. In BE 2015-2016, a sum of Rs.2,00,000/- has been provided for this purpose. Therefore, additional financial commitment for the year 2015-2016 is Rs.9.04 lakhs only.
 - 8. The revision should take effect from the date of issue of order.
- 9. The expenditure sanctioned in para 7 above shall be debited under the following head of account:
 - "2204 00 Sports and Youth Services 102-Youth Welfare Programme for students I.Non-Plan-AF National Cadet Corps 72 Training (DPC 2204 00 102 AF 7203)"
- 10. The expenditure sanctioned in para 7 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2015-16. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Deputy Director General, National Cadet Corps is directed to calculate the actual amount required for the period upto next supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I/Edn-I)
