2. The Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to sanction a sum of Rs.430.00 lakhs (Rupees four hundred and thirty lakhs only) to Sports Development Authority of Tamil Nadu to present the High Cash Incentives to all the above said 13 medal winners from Tamil Nadu.

3. The Government after careful consideration, sanction a sum of Rs.4,30,00,000/- (Rupees four crores and thirty lakhs only) to Sports Development Authority of Tamil Nadu to present the High Cash Incentives to all the above said 13 sportspersons from Tamil Nadu who have won medals at 17th Asian Games held at Incheon, South Korea from 19th September to 4th October 2014.

4. The amount sanctioned in para 3 above shall be debited under the following Head of account:

"2204.00. Sports and Youth Services-104. Sports and Games-I. Non-Plan-AR. Grants to Sports Development Authority of Tamil Nadu for Financial assistance to Sportsmen-09. Grants-in-aid-01. Grants for Current Expenditure" (DPC 2204 00 104 AR 0917).

5. Necessary funds will be provided in FMA 2014-15. However, this expenditure shall be brought to the notice of the Legislature, by specific inclusion in the Supplementary Estimates 2014-15. Pending provision of additional funds in FMA 2014-15, the Member Secretary, Sports Development Authority of Tamil Nadu is authorized to draw and disburse the amount sanctioned in para 3 above. The Member Secretary, Sports Development Authority of Tamil Nadu is requested to include the same in the proposal for FMA 2014-15 and also submit necessary Supplementary note to the Government in Finance (BG-I/Edn-I) Department at appropriate time, without fail.

6. The Member Secretary, Sports Development Authority of Tamil Nadu is authorized to present the bill to the Pay and Accounts Officer, Secretariat, Chennai-9, through Under Secretary to Government, Youth Welfare and Sports Development Department, Secretariat, Chennai-9. The above sanctioned amount shall not be paid in cash but shall be credited to the following head of account:-
