- 1. All Local bodies Co-operative Societies and private Vakalaths before the Chief Court should be entrusted only to the State Government Pleader.
- 2. All Local Bodies, Co-Operative Societies and private Vakalaths of all Courts, other than the Chief Justice Court, to be pooled together and allotted on rotation basis in the following order:
 - a) Government Advocates
 - b) Additional Government Pleaders
 - c) Special Government Pleaders
- 3. Team of Law Officers allotted for the concerned Courts are instructed to attend respective Court cases scrupulously henceforth.

- 4. Concerned Special Government Pleader to be in charge of his/her entire team of the allotted Court and the Special Government Pleaders shall once in every fortnight submit a report to the State Government Pleader with respect to status of cases.
- 5. The necessary instructions will be issued whenever situation warrants for effective and smooth administration of the Office of the State Government Pleader.
- 6. Portfolio and sitting arrangements made in Roc No. 41/All/2022-13, dated: 16.09.2022 shall cease henceforth. The above instructions should be adhered to strictly.
