CITIZENS' CHARTER- 2015 DEPARTMENT OF HANDLOOMS AND TEXTILES

1. INTRODUCTION

The major objective of Department of Handlooms and Textiles is to preserve, promote and develop the handloom and textile industry and also implement welfare measures for the handloom weavers through primary and Apex Weavers' Co-operative Societies. The Director of Handlooms and Textiles has the general and overall responsibility for initiating appropriate measures for the successful functioning of the spinning and textile Mills, hosiery Units, handloom and the powerloom industry in the State. The Directorate is also responsible for planning, formulating, implementation and effective monitoring of all the Schemes of the Government at State Level. There are 20 Circle Deputy Directors / Assistant Directors of Handlooms and Textiles, who implement all welfare developmental schemes of the Government and also over-see the functions of the Handloom and Powerloom Weavers' Co-operative Societies at the grass-root level.

At the Head Office, the Director of Handlooms and Textiles is assisted by the following Officers:
