#### PRESS RELEASE

1. The collection of Annual tax for Non-transport vehicles such as <u>Cars</u>, <u>Jeeps, Motorcycles etc.</u>, for the year 2008-2009 will be undertaken from 26<sup>th</sup> March 2008 to 10<sup>th</sup> April 2008 between 10.00 AM and 1.30 PM on all working days, including Saturdays <u>except</u> Sundays and other Government Holidays, in all the Regional Transport Offices and Unit Offices all over Tamil Nadu.

2. In order to enable the public to pay the tax without any difficulties, additional and special counters at the following places will be opened in addition to the regular counters at <u>ten</u> Regional Transport Offices (including Meenambakkam) and Unit offices Red Hills, Poonamallee and Tambaram.

3. All Non-Transport vehicles that have completed 15 years from the date of their registration have to pay "Green Tax" which is effective from 1.8.2003. Those who have not yet paid the Green Tax, shall have to pay the tax at the time of paying annual motor vehicles tax. The public are requested to make use of these additional facilities and pay the motor vehicles tax in time to avoid payment of penalty.

4. Two wheelers registered prior to 1.4.89 now paying annual tax have the option of paying the annual tax or life time tax, depending upon their age. We shall appeal to vehicle owners to make use of this options of paying the lift time tax. However, this facility is available <u>only at the Regular Counters of Regional</u> <u>Transport Offices and Unit Offices.</u>
