

Press Release

The Special Summary Revision of Electoral Rolls of intensive nature, 2019 announced by the Election Commission of India is under way.

2. To monitor the roll revision process, the Election Commission of India has appointed 10 senior IAS officers as Electoral Roll Observers. The Electoral Roll Observers will monitor the Electoral Roll revision process in three or four districts allocated to them. They will make at least three visits to the districts allocated to them during the entire period of revision. They will visit some of the polling stations in the districts, convene meetings with the representatives of the political parties and meet the public for any roll related complaints/issues. After their visits, they will submit report to the Election Commission of India.

3. As per the directions of the Election Commission of India, the Chief Electoral Officer held a briefing session to the Electoral Roll Observers on 05.09.2018.

4. The name, designation of the Electoral Roll Observers and the districts allocated to them are indicated in the annexure.
