An MoU for an investment of Rs 500 crore with Caterpillar was signed in the presence of the Hon'ble Chief Minister of Tamil Nadu, Thiru. M.K. Stalin.

On 11th September 2024, in Chicago, USA, an MoU was signed between the Government of Tamil Nadu and Caterpillar in the presence of Hon'ble Tamil Nadu Chief Minister, Thiru. M.K. Stalin. This agreement pertains to the expansion of Caterpillar's existing construction equipment manufacturing facilities in the Tiruvallur and Krishnagiri districts, with an investment of Rs 500 crore.

Tamil Nadu is attracting significant attention from both Indian and global industries, a trend that has accelerated since the government led by Hon'ble Chief Minister Thiru. M.K. Stalin took office three years ago. The state's higher education enrollment ratio, which is above the national average, has resulted in a skilled workforce, drawing many foreign companies to invest in Tamil Nadu. Additionally, the state has been establishing sector–specific industrial parks equipped with world–class infrastructure to further boost industrial growth.
