

**PRESS RELEASE**

To envisage a Right of Person with Disabilities Act 2016 for the Welfare of Differently abled persons and formulate schemes relating to health care, rehabilitation, Insurance schemes, research and development in the field of Right of Person with Disabilities, recreation and culture, sporting activities, awareness campaign, accessibility, human resource development etc. and to raise fund for Person with Disabilities schemes and in order to provide Legal Assistants and also for implementing the statutory provisions of the Right of Person with Disabilities Act, 2016. It is proposed to engage one Legal Consultant on contract basis. It is proposed to engage one Project Consultant and one Legal Consultant on contract basis for the Office Director for Welfare of the Differently abled / State Commissioner for Persons with Disabilities

**LEGAL CONSULTANT****Educational qualification:**

- 1.Practicing Advocate / candidate with a valid B.L / L.L.B degree.
- 2.Should describe his /her legal experience including the names, addresses, contact persons and telephone numbers of at least three clients.
- 3.Should have minimum 5 years of work experience. Preference will be given to the candidates who have work experience in a registered non-profit organization and experience in advising clients conducting similar programs and government funded services.

**Age limit :** Upper age limit is 35 years on the last date of submission of application.

**Language:** The Legal Consultant should be proficient in English and Tamil.

**Remuneration:** Honorarium Rs.50,000 to Rs.75,000/- per month shall be fixed based on qualification and experience of selected candidates.

**Duration of engagement:** Initially for a period of one year and extendable up to 3 years based on annual performance review. The State Commissioner for Persons with Disabilities can terminate the service of legal consultant.

**Remuneration:** Honorarium Rs.50,000 to Rs.75,000/- per month shall be fixed based on qualification and experience of selected candidates.
