

TAMIL NADU STATE ELECTION COMMISSION PRESS RELEASE

Press Release No. 8/2010

Dated 14.07.2010.

Casual elections to fill up the vacancies, which have occured upto 30.04.2010 in the offices of local bodies are scheduled to be held on 22.07.2010. Nominations were received from 03.07.2010 to 10.07.2010. Scrutiny of nominations taken place on 12.07.2010. The last date notified for withdrawal of nomination is 14.07.2010. The no. of contestants in the elections are as follows:

Rural Local Bodies

Out of the 840 offices notified, candidates were elected unopposed in 557 offices. No nominations were filed for 60 offices. A total no. of 620 contestants are in the fray for 223 offices for which poll is to be taken place on 22.07.2010.

Urban Local Bodies

Out of the 83 offices notified, candidates were elected unopposed in 40 offices. No nominations were filed for 8 offices. A total no.of 100 Contestants are in the fray for 35 offices for which poll is to be taken place on 22.07.2010.
