## WORKSHOP ON FORMULATION OF STATE POLICY FOR WOMEN

A workshop on formulation of State Policy For Women was conducted by The Department of Social Welfare And Women Empowerment, Tamilnadu, on 12.08.2021, at Chennai, under the Chairmanship of Hon'ble Minister for Social Welfare and Women Empowerment Department.

In her special address, she emphasized that Livelihood, Protection and Rights of Women need to be taken into account on formulation of the State Policy. She further added that Women are engaged in many unrecognized work in various unorganized sectors including domestic work, and are not paid equal wages as compared to men, especially in agriculture and fisheries sectors. Also Every Women should have the Right to choose her own choice and make her own decision and should be freed from all forms of violence including domestic violence.
