

**EMPLOYMENT OPPORTUNITIES IN GOVERNMENT DEPARTMENTS/PUBLIC
SECTOR UNDERTAKINGS UNDER 3% RESERVATION SPORTS QUOTA**

Government of Tamil Nadu has been implementing various initiatives / schemes for the development of sports and Games in Tamil Nadu State. In order to encourage sportspersons from Tamil Nadu who have participated in Olympic and other international level competitions and won medals are being offered employment in Government Departments / Public Sector Undertakings (PSUs) under 3% reservation as per Government order.

Achievements in the following Competition / Tournaments on or after 01.01.2018 will be considered as eligible for employment under this scheme.

International Competitions: (Medalist / Participants)

- Summer Olympic Games
- Commonwealth Games
- Asian Games
- World Championships conducted, either once in 4 years or once in 2 years or annually, by International Sports Federation (ISF) recognised by International Olympic Committee (IOC).
- Commonwealth Championships conducted, either once in 4 years or once in 2 years or annually, under aegis of ISF recognised by IOC.
- Asian Championships conducted, either once in 4 years or once in 2 years or annually under aegis of ISF recognised by IOC.
- South Asian Federation Games (SAF Games)
- Paralympic Games
- Asian Para Games
- International Blind Sports Association (IBSA) World Games and Deaflympics organised by International Committee of Sports for the Deaf.

National level competitions : (Medalist Only)

- National Games
- National Championships conducted by National Sports Federations recognised by Ministry of Youth Affairs and Sports.

State Championships : (Medalist Only)

Conducted by State Sports Associations recognised by Sports Development Authority of Tamil Nadu (SDAT) . Among all the levels of competitions, only senior level competitions are eligible for consideration.

Age Eligibility Criteria:

- The sportspersons should fulfill all the minimum educational qualification criteria prescribed for the post
- However, the maximum age limit upto 40 years.

As per the above guidelines, the applicants must be a native of Tamil Nadu for getting employment under the 3% Sports Quota. Sportspersons are instructed to upload their application along with necessary documents on the Website www.sdat.tn.gov.in. or requested to download the application form and apply along with necessary documents offline and submit at the Head Office, Jawaharlal Nehru Stadium, Periyamet, Chennai-3 **on or before October 31, 2023, by 5:00 p.m.**
