

**COMMITTEE TO REGULATE-MONITOR THE ADMISSIONS OF STUDENTS TO PROFESSIONAL COURSES BY THE SELF FINANCING PROFESSIONAL, ARTS AND SCIENCE COLLEGES.**

As per the directions of the Hon'ble Supreme Court in the judgements in 1) Islamic Academy and others Vs State of Karnataka and 2) P.A. Inamdar and Others Vs State of Maharashtra and Others, Tamil Nadu Government have constituted a Committee named as Committee to Regulate-Monitor the Admissions of students to Professional courses by Self Financing Professional, Arts and Science Colleges headed by Hon'ble Mr. Justice **A.Abdul Hadi** to ensure Fair, Transparent and Non exploitative in the admissions of students to the Professional courses to the seats retained by the Private Unaided (Self Financing) Professional Institutions.

For Medical/Indian System of Medicine/Paramedical courses, Tmt. Girija Vaidyanathan I.A.S., Principal Secretary to Government, Health and Family Welfare Department is the Member-Secretary of the Committee; the other members are Dr. Mayilvahanan Natarajan, Vice Chancellor, The Tamil Nadu Dr. MGR Medical University, Dr. K. Ananda Kannan and Dr. S.K. Rajan.

The Committee issued Public Notice in the dailies " The Hindu ", and "Daily Thanthi" on 26.06.2011 (Tamil Nadu Edition) requiring the Consortium / Association/Institutions/Colleges imparting MBBS /BDS /B.Sc.Nursing / B.Pharm/B.O.T/B.P.T/Indian System of Medicine courses, to appear before the Committee for finalisation of the procedure to be followed in the selection and admission of students to the above said courses for the academic year 2011-2012, for the seats retained by the respective institutions.

Pursuant to the publication, representatives of the relevant Colleges, the representative of the Tamil Nadu Private Professional Colleges Association - Health Sciences and the representatives of the Tamil Nadu Recognised Nursing Schools and Colleges Association, appeared before the Committee on 05.07.2011 and 05.08.2011. In this regard the Committee meetings were held on 05.07.2011, 05.08.2011 and 17.08.2011.

The Committee permitted the Tamil Nadu Private Professional Colleges Association – Health Sciences, to carry out the process for admission of students to the seats retained by the institutions for the U.G. courses of Medical, Dental, Paramedical and Indian System of Medicine in respect of their respective member institutions. The Tamil Nadu Recognised Nursing Schools and Colleges Association, Chennai has been permitted to carry out the admission process for admission of students to B.Sc.(Nursing) course only, in respect of their 67 member institutions.

Students and their Parents may find out the details of the member colleges and the schedules of admissions for different courses, from the Website of the above two Associations, namely.

As only these two Associations have been authorized by the Committee to carry out the admission process for the retained seats of their member institutions, admissions made directly by the member institutions themselves or any other institutions **shall not be valid**. Hence students and their Parents are advised to get the application forms through the above said two Associations only.
